COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, April 7, 2014 at 6:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairperson Deborah F. Brown, Commissioners Archie B. Taylor, Jr., Dan Brummitt, Terry E. Garrison, Thomas S. Hester, Jr., Gordon Wilder, and Eddie L. Wright.

Absent: None.

Also present were County Manager Jerry L. Ayscue, Finance Director David C. Beck, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Rev. Joseph Ratliff, Shiloh Baptist Church, gave the invocation.

Chairperson Deborah F. Brown recognized the participants of Leadership-Vance 2014 who were present. The participants introduced themselves and stated their occupation and place of work. Chairperson Brown thanked the group for being present at the meeting and for taking an interest in Vance County Government.

Next, Chairperson Brown recognized several Boards and Committees that work on behalf of the Board of Commissioners. Those recognized were members of the KARTS Board, the Library Board of Trustees, the Nursing Home Advisory Committee, the Henderson-Vance Recreation Commission, the Research Triangle Regional Partnership Board, and the Rural Transportation Advisory Committee. Chairperson Brown thanked the members for all they do on behalf of the Board of Commissioners and the citizens of Vance County. Each member will receive a Vance County lapel pin.

Before public comments were heard, Commissioner Terry E. Garrison stated that during a previous meeting, the Board discussed whether or not a men's homeless shelter was eligible to receive a tax exemption. He asked the County Attorney about the status of this matter. Attorney Care stated that he has looked into this matter and has had discussions with Ms. Porcha Brooks, Tax Administrator. Last week, Ms. Brooks asked Attorney Care to provide a written opinion to the Department of Revenue because the Department of Revenue is interpreting the State Statute differently than Attorney Care. Part of the misinterpretation is under which particular Section or Statute of the exemptions it is applied. One has a requirement of use and occupancy, and the other one does not. Attorney Care stated that in his opinion, the shelter should qualify for the tax exemption. He will keep the Board posted on this matter.

Public comments were heard next. Mr. Lawrence Brame stated that he had received a brochure in the mail from Envirolink. The brochure compares minimum water rate charges for Vance County, City of Henderson, Franklin County, South Granville, and Warren County. The brochure indicates that Vance County's minimum rate is \$30. It also indicates that the City of Henderson's minimum charge (for county residents) is \$25.18. He stated that this is different from information he received from the City. He also spoke in opposition to the tap on rates of \$325 and \$1,995.

Chairperson Brown requested the Water Planning Committee to address the brochure that Mr. Brame referenced.

Committee Reports and Recommendations

Human Resources Committee - Position Vacancies. County Manager Jerry L. Ayscue requested the Board to allow filling the following position vacancies which have been endorsed by the Human Resources Committee:

Jail Detention Officer

Emergency Operations Telecommunicator

<u>Social Services</u> Processing Assistant IV

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Gordon Wilder, vote unanimous, to approve filling the position vacancies as presented.

Human Resources Committee - Economic Development Commission Vacancies. Mr. Ayscue stated that inasmuch as there are several well-qualified applicants for the two vacant EDC positions, the committee agreed that further information/data about those interested in serving would be very helpful in determining the best individuals to serve. Therefore, the committee is in the process of developing a questionnaire that will seek more detailed information from those who have expressed interest in the positions. A further report will be made to the full Board in its May meeting.

Technology Committee. Mr. Ayscue reported that this committee met on March 27 and discussed several items that were assigned by the Board of Commissioners as discussed in the Board's Planning Retreat. Those items were a possible technology controls audit (primarily

security oriented), consolidation of the data center, and use of social media to promote the County.

Technology Controls Audit. With input from staff, the committee discussed whether or not a controls audit is necessary. After extensive discussion, it was decided that policies and procedures should be developed and put into place before proceeding with plans for a technology controls audit. The IT Director will contact other counties and cities to obtain copies of similar policies and procedures for potential customization for Vance County. The committee will meet again in thirty days to review those model policies.

Consolidation of Data Center. It was suggested to the Board that the County's data center should be relocated from the Administration Building to the Schools' Central Office. The staff has already begun to locate some of its servers in the Courthouse and is confident that is a responsible plan of action. The Courthouse is more physically secure, is accessible around the clock, and has an existing generator. The committee was supportive of this strategy.

County Use of Social Media. Numerous County departments are currently using some form of social media (Facebook, Twitter, LinkedIn, etc.) It was determined that a formal policy regarding the appropriate use of social media as a means of promoting the County is in order. The staff will develop a policy and present to the committee for review.

Properties Committee. Mr. Ayscue stated that this committee met on April 1 to discuss guidelines for use of the Farmers Market by outside groups, and properties now owned by the County due to property tax foreclosures.

Farmers Market Use Guidelines. The Farmers Market Advisory Committee recommended a set of guidelines for use of the facility when it is not being used for its primary purpose. The Board of Commissioners asked the Properties Committee to review the guidelines and make a recommendation back to the full Board. The Committee is in the process of reviewing the proposed guidelines and expects to make a report to the full Board in a future meeting.

Foreclosure Properties. The committee was made aware of the two types of properties in which the County has ownership – those that are outside City limits and now owned totally by the County as a result of foreclosure, and those foreclosure properties that are located inside the City and thus owned jointly by the County and City. These properties were offered for public sale by the tax foreclosure attorney, but were not purchased. The committee decided that the

best way to proceed would be to engage the services of a professional auction firm that will use, at a minimum, electronic and other means of auctioning/selling the properties. It was decided to first sell the properties owned solely by the County and then to pursue the sale of the jointly owned properties. All offers will require action by the full Board of Commissioners prior to final sale. Recommendation: Authorize the Properties Committee, with staff assistance, to develop and distribute a Request for Proposals/Qualifications for a professional auction firm to market and sell County-owned properties obtained through tax foreclosures.

Motion was made by Commissioner Thomas S. Hester, Jr. to authorize the Properties Committee, with staff assistance, to develop and distribute a Request for Proposals/Qualifications for a professional auction firm to market and sell County-owned properties obtained through tax foreclosures. This motion was seconded by Commissioner Archie B. Taylor, Jr. and unanimously approved.

Sale of Armory. Mr. Ayscue stated that the committee met on Monday, April 7 to review the proposals submitted by four auction firms for the marketing and sale of the Armory property. After discussion, the committee determined that Rogers Realty & Auction Co., Inc. of Mt. Airy, NC seemed to be the best option for the County. Recommendation: Authorize the Chairperson to execute a contract with Rogers Realty & Auction Co., Inc. that is compliant with NC Statutes regarding disposition of County property for an absolute auction of the Armory property on Dabney Drive. Further, authorize the Properties Committee to approve the final marketing plan and related expenses.

The bids were submitted as follows:

Commissioner Terry E. Garrison stated that there should be some stipulations put into place as far as the disposition of the property after it is sold. Attorney Care stated that the property is being put up for absolute auction with final approval being required by the Board of Commissioners. At this point, there has not been discussion about any type of covenant on how quickly the property has to be refurbished or demolished. Attorney Care suggested that we discuss this matter with Rogers Realty and let them know that we are in the process of developing the exact terms and conditions of the sale. This can be incorporated into their contract.

Motion was made by Commissioner Terry E. Garrison to authorize the Chairperson to execute a contract with Rogers Realty & Auction Co., Inc. that is compliant with NC Statutes regarding disposition of county property for an absolute auction of the Armory property on Dabney Drive. Further, to authorize the Properties Committee to approve the final marketing plan and related expenses, and to develop the criteria and conditions upon which this sale is based. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Ms. Karen Foster, Council of Governments, appeared before the Board requesting approval of CDBG Compliance Documents for the Section 504. She explained that every few years, anyone who is receiving CDBG funds is obligated to submit this compliance package to the State.

Commissioner Dan Brummitt noted that there are several typographical and grammatical errors throughout the document. He asked that these be corrected.

Motion was made by Commissioner Dan Brummitt to approve the Section 504 Plan Compliance documents contingent upon all typographical and grammatical errors being made and submitted to County staff for final approval. This motion was seconded by Commissioner Thomas S. Hester, Jr. and unanimously approved.

Commissioner Terry E. Garrison asked Ms. Foster for an update on the Neighborhood Stabilization Program houses. Ms. Foster stated that there are currently two pending offers on the table and are in process and expected to close.

Water District Board

Chairperson Deborah F. Brown called the Water District Board to order.

Project Update. Jordan McMillen, Planning Director and Deputy County Manager, reported on Phase 1A and stated that word was received on March 20th that six out of seven of the first road additions were certified and are in use. Permits were received for the booster pump at the Phase 1A tank, and construction is anticipated to take place over the next 60 to 90 days. Permits have also been received for the second group of road additions. Three informational

meetings were held this past month with strong turnouts, and two more are scheduled for this week.

Tim Carpenter, LKC Engineering, provided an update on Phase 2. He stated that as of today, approximately 35% of pipeline installation is complete. The steel is on the ground for the water storage tank, with construction to begin toward the end of this month. With so much rainy weather over the past few days, DOT has expressed concerns with erosion control. Mr. Carpenter stated that these concerns will be addressed as quickly as possible. The meter vault and booster pump modifications are complete.

Change Orders. Mr. McMillen requested approval of Change Order #7 for Contract 1 in the amount of \$92,899.40 for installation and configuration of the SCADA system for the water tank, for the purchase and installation of 16 automatic flush devices, and for electrical service at the meter vault site for security and operational purposes. He provided the following overview:

SCADA. Supervisory Control and Data Acquisition or SCADA provides a mechanism for monitoring and controlling the tank in real time using remote terminals. This provides the ability to locate, respond, and alleviate waterline breaks and other forms of high usage in a much quicker time period. This particular system is a requirement of the Kerr-Lake Regional Water Authority and the City of Henderson and will allow the water plant to see and inform the County of issues in real time. This installation will be coordinated with the City of Henderson and Kerr Lake Regional Water System and will assist in maintaining system tank levels and adequate water supply for customers. The installation will include locating modules and an antenna at the elevated water tank as well as setup and configuration with the existing telemetry system at the Kerr Lake Regional Water Plant. Total cost for the SCADA is \$42,976.37

Automatic Flushing Devices. System flush boxes are required to maintain required free chlorine levels throughout the system. Flush boxes will provide the most efficient means to control water flushing when needed. This quote is to purchase (15) Eclipse 9700 flush boxes and (1) Eclipse 9700i monitoring flush box. This number of flush boxes will serve to move water through the system efficiently. All flush boxes are portable; the monitoring flush box can be moved to different locations to set parameters for non-monitoring boxes. The total cost is \$39,076.79.

Electrical Service at Meter Vault Site. Electrical service for Meter Vault 1 is to provide security and operational support to maintain the meter vault. This includes a meter base, security light, and electrical power to operate vault sump pumps. The total cost is \$10,846.24.

After discussion, motion was made by Commissioner Thomas S. Hester, Jr. to approve Change Order #7 for Contract 1 in the amount of \$92,899.40 for installation and configuration of the SCADA system for the water tank, for the purchase and installation of 16 automatic flush devices, and for electrical service at the meter vault site for security and operational purposes. This motion was seconded by Commissioner Terry E. Garrison and vote was ayes - six (6); noes - one (1), with the dissenting vote being cast by Commissioner Gordon Wilder.

Additional Items. Mr. McMillen stated that in order to avoid coming back for further approvals on these items, it is recommended by the engineer to provide the approval of the following allowances:

- \$5,000 if needed for placement of necessary power to the tank site from the main road. Funds would be set aside to pay Duke Energy for any related service charges.
- \$6,500 necessary chemical (chlorine treatment) for tank 1 in association with the booster pump installation.

Mr. McMillen requested approval of the allowances not to exceed \$5,000 for phase 3 power if necessary and not to exceed \$6,500 for chlorine treatment of the tank from project contingency funds.

Commissioner Dan Brummitt questioned why these funds need to come from Contingency if there are still funds available in the budget. Mr. McMillen responded that the funds may come from the regular budget if the Board wishes to do so, but in order to maximize the grant funds, you need to pull the Contingency down.

Chairperson Deborah F. Brown expressed her concerns with pre-approving funds.

Estimated Design and Inspections for First and Second Group of Road Additions. Mr. McMillen stated that based upon the submitted construction costs for all road additions to date, the USDA fee curve was used to estimate design and inspection costs as a result of adding the first and second group of road additions (14 roads). The additional design for these roads totals \$20,415. The estimate for inspections based upon the USDA reimbursement rate is estimated to be \$61,478 for all of these road additions. The actual value of this work is contingent upon actual hours spent on site which are verified through work log submittals.

Mr. McMillen requested approval of additional engineering fees of \$81,893 for design and inspection of the first and second group of road additions to be utilized from project Contingency funds. Work logs will be submitted confirming inspection hours on site.

Chairperson Deborah F. Brown expressed her concerns with pre-approving funds before work logs are submitted confirming inspections hours on site.

Commissioner Dan Brummitt asked for clarification on the amount of work that has already been performed. Mr. McMillen stated that \$61,478 worth of work has already been performed. The remaining amount, up to \$81,893, is for work that will be performed on the next group of roads. Commissioner Brummitt asked for clarification on the following: 1) it is anticipated that the phase 3 power will be needed within the next 30 days, 2) the chlorine treatment will not be needed, and 3) we are already obligated on the \$61,478. Mr. McMillen responded that this is correct.

Motion was made by Commissioner Dan Brummitt to approve the allowance of \$5,000 for phase 3 power and approve additional engineering fees for design and inspection in the amount of \$61,478. This motion was seconded by Commissioner Terry E. Garrison and vote was ayes - six (6); noes - one (1), with the dissenting vote being cast by Commissioner Gordon Wilder.

Envirolink Monthly Report. Mr. J.P. McCann, Envirolink, presented the March 2014 service report which included information on work order completions, satellite office activity, and billing summaries. Commissioner Dan Brummitt requested that year-to-date totals be included in future reports as well as monthly totals. The Board discussed the water main break that occurred in February. Chairperson Brown expressed her displeasure with the \$30 base fee that is being charged to customers. The Board thanked Mr. McCann for his report.

Water Planning Committee Report. Mr. Ayscue stated that this committee met on April 2 and discussed two items requested by the Water Board -1) refund of signup deposits and 2) reduction of the monthly base fee charge from \$30 to \$20 for those who signed up but have decided not to connect to the water system. The committee also discussed pursuit of additional grants to increase utilization by extending the system and making sure that those who receive their refunds will have that same signup fee "reserved" into the future should water be made available to them.

Refund of Deposits. The Water Planning Committee determined that it is time to refund deposits (\$125) for those residents who initially signed up, but it is clear now that water service will not be available to them in the foreseeable future. A list of roads was thoroughly reviewed. Upon approval by the Water Board to start issuing refunds, a letter will be sent to the residents on those roads who signed up, notifying them that they will receive a refund in approximately thirty days after receipt of the refund notice. Committee's Recommendation: Approve the issuance of refunds to residents on the roads as presented (first wave of refunds).

Motion was made by Commissioner Eddie L. Wright to approve the issuance of refunds to residents on the roads as presented (first wave of refunds). This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Reservation of \$125 Signup Fee Level. In related discussion, the committee believes that those residents receiving refunds should be able to "re-signup" at the same \$125 fee in the future if water is made available to them. Committee's Recommendation: Allow residents who receive refunds to "reserve" the initial signup fee of \$125 if water service is made available to them in the future.

Motion was made by Commissioner Dan Brummitt to allow residents who receive refunds to "reserve" the initial signup fee of \$125 if water service is made available to them in the future. This motion was seconded by Commissioner Archie B. Taylor, Jr. and vote was ayes - six (6); noes - none. Commissioner Gordon Wilder abstained because he is included in this group of residents.

Reduction of Base Fee. Mr. Ayscue stated that after careful deliberation, the committee decided that the base fee should remain at \$30 per month. The annual budgetary impact of reducing the charge to \$20 for all three phases for those who signed up but do not connect is about \$50,000. If the monthly base fee is reduced to \$20 for everyone, it would have an adverse impact of about \$117,000 per year. There was no recommendation from the committee to change the \$30 base fee.

Chairperson Deborah F. Brown disagreed with the committee and stated that residents who signed up four years ago and agreed on a \$20 base fee should not be required to pay \$30. The County should honor the \$20 base fee. Anyone who signs the new contract with the \$30 base fee should pay \$30.

Pursuit of Grants. Mr. Ayscue explained that in recent months, additional grant opportunities have become available for infrastructure. The committee supports the pursuit of those grants if the County meets the necessary requirements. Committee's Recommendation: Authorize the staff to work with the County's engineering firm and other resources to pursue grants to provide additional water service in the County.

Motion was made by Commissioner Gordon Wilder to authorize the staff to work with the County's engineering firm and other resources to pursue grants to provide additional water service in the County. This motion seconded by Commissioner Archie B. Taylor, Jr.

Chairperson Deborah F. Brown asked why these grants are being pursued now and were not pursued earlier. Mr. Ayscue explained that these are new grants and have just become available.

Vote on the motion was unanimous.

Foster Road. Mr. Ayscue stated that additional clarification is needed involving the Foster Mobile Home Park at 1000 Foster Road. There are 45 signups at the MHP and another nine along the way. Currently, funding is not available to reach that distance in Phase 1A. The Kittrell Water Association has expressed an interest in serving this area. The committee recommends holding on to the signups within this area to allow staff and engineers to explore funding options. Ultimately, if grant funds cannot be obtained, the committee feels it would be wise to have discussions with KWA in regards to their service of that area.

Commissioner Dan Brummitt stated that the committee recommends that the County proceed to allow Kittrell Water Association to pursue funding for Foster Road.

Commissioner Gordon Wilder stated that the signups in this area are significant to the total that is needed to run water down Hwy 39. He agrees that those customers need to be put into KWA's proposal also, but what he does not want to happen is that we lose those signups to Kittrell and then we do not have the numbers we need to run water down Hwy 39.

Commissioner Terry E. Garrison agreed and stated that wherever the funds are available is where the water should be provided from. He is hopeful that grant funding will become available for the Foster Road area.

Commissioner Archie B. Taylor, Jr. stated that it was his understanding that Kittrell Water Association does not have the funding for this area at this time, but if they were to obtain the funds first, then they should provide the service. Tim Carpenter, LKC Engineering, stated that KWA is about to make an amendment to their Preliminary Engineering Report to USDA. USDA has given them all indication that they will be funded or given a letter of conditions shortly. The question raised in the committee meeting was can KWA include that funding request in their application. If so, they would like the Water District Board to support their request.

Attorney Jonathan S. Care stated that USDA will not allow funding where there is already other USDA funding of another system. If KWA is approved and then we find alternative sources of funding through grants, depending on the source of those grants, they would not be allowed to be used on a project that competes with USDA.

Commissioner Terry E. Garrison requested Mr. Carpenter to contact USDA and make them aware of our desire to provide water to as many citizens as possible. Mr. Carpenter encouraged both the Vance County Water District and the Kittrell Water Association to pursue funding.

To clarify, both the Vance County Water District Board and the Kittrell Water Association should pursue funding for Foster Road.

Motion was made by Commissioner Terry E. Garrison to pursue both funding opportunities to provide water to residents on Foster Road, including Foster's Mobile Home Park. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Chairperson Deborah F. Brown adjourned the Water District Board.

Finance Director's Report

Armory Building - Contract with Auction Company. This item was acted upon earlier during the meeting.

County Financial Audit. Finance Director David C. Beck explained that County staff had prepared and distributed a Request for Proposals seeking proposals from CPA firms to audit the County's financial information for the next three fiscal years. The following is a summary of the proposed costs as well as relevant experience:

After a brief discussion, motion was made by Commissioner Dan Brummitt, seconded by Commissioner Eddie L. Wright, vote unanimous, to execute a three year contract for County auditing services with Carr Riggs & Ingram.

Financial Review/Audit - Volunteer Fire Departments. Mr. Beck stated that Requests for Proposals were distributed to prospective CPA firms to provide financial reviews/audits for participating volunteer fire departments. He explained that participation in the contract is voluntary for the fire departments. Initial participation from five volunteer fire departments is anticipated. Three CPA firms responded to the RFP as follows:

*Participation in Year 1 is five volunteer fire departments.

County Manager Jerry L. Ayscue noted that the Public Safety Committee had discussed that in the event that a volunteer fire department that is not participating in this arrangement uses another CPA firm at a higher rate, the County would provide funds to that volunteer fire department not to exceed the RFP amount listed above. If the audit is less than the RFP amount, the County would pay the lesser amount.

Motion was made by Commissioner Gordon Wilder to contract with Phillips, Dorsey, Thomas, Waters & Brafford to provide financial reviews for Years 1 and 2, and an audit for Year 3 to the volunteer fire departments that wish to participate. This motion was seconded by Commissioner Eddie L. Wright and unanimously approved.

County Manager's Report

Spring Litter Sweep Proclamation. In the spring and fall of each year, the NC Department of Transportation sponsors cleanup campaigns to beautify the roadsides of the State. In support of the upcoming Spring Litter Sweep, the Board of County Commissioners is asked to approve a proclamation urging all citizens to become involved in making Vance County cleaner,

safer, and more aesthetic. Mr. Ayscue requested approval of the proclamation designating April

26 – May 10, 2014 as Spring Litter Sweep in Vance County.

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Thomas

S. Hester, Jr., vote unanimous, to approve the following proclamation designating April 26 -May 10, 2014 as Spring Litter Sweep in Vance County:

R E S O L U T I O N by the Vance County Board of Commissioners in Recognition of the 2014 Spring Litter Sweep

- **WHEREAS**, in conjunction with the North Carolina Department of Transportation, Vance County supports and encourages participation in the Spring 2014 roadside cleanup effort to ensure clean and beautiful roads throughout the County; and
- WHEREAS, the Spring 2014 Litter Sweep roadside cleanup campaign will occur April 26 -May 10. The County urges all communities, civic and professional groups, businesses, churches, schools, families, and individual citizens to participate in the cleanup effort by sponsoring and organizing roadside cleanup teams; and
- WHEREAS, Adopt-A-Highway volunteers, community service workers, community leaders, civic and community organizations, businesses, churches, schools, and environmentally concerned citizens conduct local cleanups during Litter Sweep and may receive Certificates of Appreciation for participation; and
- **WHEREAS**, the natural beauty of our State and County, in addition to a clean environment, is a source of great pride for all Vance County residents, attracting tourists and aiding in the recruiting of new industries; and
- WHEREAS, the cleanup effort will increase the awareness of the need for cleaner roadsides, emphasize the importance of anti-litter campaigns, and emphasize the recycling of solid wastes such as glass, metals, and plastics; and
- **WHEREAS**, the Litter Sweep cleanup will be a part of educating the children and citizens of the County regarding the importance of a clean environment to the quality of life in Vance County.
- **NOW, THEREFORE BE IT PROCLAIMED**, that the Vance County Board of Commissioners does hereby recognize April 26 May 10, 2014 as "Spring Litter Sweep" in Vance County and encourages all citizens to take an active role in making the community a cleaner and more beautiful place in which to live.

Scalehouse Bids. Mr. Ayscue reported that quotes have been received to replace the small landfill scalehouse. Three quotes were obtained and the lowest is \$9,670 by Jimmy Lawrence (the original builder). The other two quotes are J. Ramsey - \$13,000 and Tarheel

Woodcrafters - \$14,232. Supervision of the building of the scalehouse will be by inspectors in the Planning & Development Department. The cost of this work will be covered by insurance proceeds, subject to the normal \$1,000 deductible.

Motion was made by Commissioner Dan Brummitt to approve the selection of Jimmy Lawrence as the lowest quote in the amount of \$9,670 to replace the landfill scalehouse. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

Intergovernmental Committee Meeting Request. The County recently submitted a request to the City of Henderson to reactivate its Intergovernmental Committee appointees so the "joint committee" could meet as a means of adequately planning for future success. About three years ago the City and County revised the traditional way of addressing joint issues by going to a single appointed liaison from each governing body. The City responded that it wanted to know why the County wanted to replace the liaison arrangement with a committee approach. It also asked that the County take official action to make the formal request during one of the Commissioners' meetings.

Commissioner Dan Brummitt stated that the single appointed liaison arrangement was for the sole purpose of discussing water sales, but this was not a formal arrangement.

Motion was made by Commissioner Dan Brummitt to inform the City of Henderson that the County wishes to reactivate the Joint Intergovernmental Committee to discuss jointly funded programs and items of budgetary concern. This motion was seconded by Commissioner Terry E. Garrison.

Chairperson Deborah F. Brown echoed Commissioner Brummitt's remarks and stated that there is not a formal arrangement with the City that appoints a single liaison to act on the Board's behalf. Also, the County would like to meet with the City regarding jointly funded programs.

Commissioner Dan Brummitt stated that reactivating the Joint Intergovernmental Committee would be an opportunity for positive conversations that could benefit the citizens of Henderson and Vance County.

Commissioner Thomas S. Hester, Jr. stated that he would like to see the Board develop a plan and/or policy on this matter instead of just voting on what it wants.

Vote on the motion to inform the City of Henderson that the County wishes to reactivate the Joint Intergovernmental Committee to discuss jointly funded programs and items of budgetary concern was ayes - six (6); noes - one (1), with the dissenting vote being cast by Commissioner Thomas S. Hester, Jr.

Commissioner Terry E. Garrison suggested that the letter be from the Chairperson to the Mayor, with copies going to City Council Members.

Leadership Vance. Mr. Ayscue reminded the Board that Leadership Vance 2014 "County Day" will be held on Tuesday, April 15. Commissioners are invited to come to the 9:00 a.m. Icebreaker Reception in Commissioners Conference Room and also to join the group for lunch at 12:00 noon.
