COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, February 3, 2014 at 6:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairperson Deborah F. Brown, Commissioners Archie B. Taylor, Jr., Dan Brummitt, Terry E. Garrison, Thomas S. Hester, Jr., Gordon Wilder, and Eddie L. Wright.

Absent: None.

Also present were County Manager Jerry L. Ayscue, Finance Director David C. Beck, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom

Pastor Brenda Peace-Jenkins, Greater Little Zion Holy Church, gave the invocation.

Before the meeting began, Chairperson Brown recognized several Boards and Committees that work on behalf of the Board of Commissioners. Those recognized were members of the 911 Advisory Board, the ABC Board, the Adult Care Advisory Committee, the Vance County Appearance Commission, the Henderson Planning Board, and the Henderson Zoning Board of Adjustments. Chairperson Brown thanked the members for all they do on behalf of the Board of Commissioners and the citizens of Vance County.

As advertised, at 6:00 p.m., a public hearing was held regarding a request to amend the zoning map and to rezone three separate parcels/tracts from Light Industrial (L-I) to Office Institutional (O-I). Mr. Jordan McMillen, Director of Planning and Development, stated that the request is from Vance-Granville Community College. The 20.998 acre area is located between US 158 Bypass and Poplar Creek Road. This rezoning would change the allowable uses of the property from one of being industrial or light manufacturing in nature to one that is more in line with a non-retail commercial nature such as professional businesses, offices, churches, and/or academic related institutional uses. With this change in permitted uses, lot sizes are allowed to be smaller with smaller setback and lot coverage requirements. While not technically considered a downzoning in density, such a rezoning would reduce the potential for large scale industrial uses that have the potential for greater environmental impacts.

The Planning Board recommended approval of the request on the basis that the revision fits the character of the area and is consistent with the Land Use Plan's designation of this area as a development or crossroads community.

As there was no one present who wished to speak on the matter, Chairperson Deborah F. Brown declared the public hearing closed.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Archie B. Taylor, Jr., vote unanimous, to approve the rezoning request by the following rationale: The rezoning request is reasonable and consistent with the County's Land Use Plan while allowing for commercial development within a designated development community.

Pending Business

VFD Contracts and Audits. Mr. Ayscue reported that all reports that are due at this time have been received. Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Gordon Wilder, vote unanimous, to accept the report as presented.

Consent Agenda

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Eddie L. As advertised, at 6:15 p.m., a public hearing was held regarding a request to amend the zoning map and to rezone one parcel from Residential Low Density (R-30) to General Commercial (G-C-1). The area to be rezoned totals one acre and includes an existing structure that is being utilized for a commercial business. Mr. Jordan McMillen, Director of Planning and Development, stated that the parcel is located at 2927 Nutbush Road and is currently the location of a boat repair business. All lots to date in this area have been zoned as they were since countywide zoning was established in November 2011. During the time that the zoning categories were being developed, this structure was in transition and therefore was not categorized as commercial zoning at that time. Additionally, because of the surrounding

residential and open space zoning designations, this property was zoned as a more compatible R-30 zoning designation.

Mr. McMillen stated that this rezoning would allow uses that are characteristic of a commercial nature. These newly allowed uses would be similar in nature as the current use. Because of the potential uses and impacts, adequate buffers and screening will be required at such time that new zoning permits are required.

Commissioner Terry E. Garrison stated that the property is currently very unsightly and asked if it was being maintained. He stated that he would like to see it cleaned up before it is rezoned. Mr. William Wortham, Jr., owner of said property, responded and stated that the current tenant is in the process of leaving and is in the process of removing the items off the property. In order to rent the property to another business/tenant, he requested that the property be rezoned. Commissioner Terry E. Garrison stated that he was okay with this as long as the property is being cleaned up.

As there were no other persons who wished to speak on the matter, Chairperson Deborah F. Brown declared the public hearing closed.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Gordon Wilder, vote unanimous, to approve the rezoning request by the following rationale: the rezoning will allow the current use of the property to more closely resemble the zoning of the property while encouraging further commercial development within a designated transitional development area. For this reason, the rezoning request is reasonable and is consistent with the County's Land Use Plan.

Ms. Cece Leahy of Phillips, Dorsey, Thomas, Waters & Brafford was next on the agenda to present the FY 2012-13 Audit Report. Ms. Leahy reported that the County had received an unmodified opinion which is the best a county can receive. The total fund balance increased by 0.6% (\$90,151) for the General Fund for a balance of \$14,791,400. The total revenues last year were \$42,374,737 which is an increase over budget by \$1.3 million. This is mainly due to ad valorem and sales taxes. Expenditures for the General Fund were \$43,204,820 which is under budget. Unassigned funds are \$7,920,222, which is 21.2% of next year's budget. This is well within what is required by the Local Government Commission. The property tax collection rate was 94.24% which is an increase over last year.

After discussion, motion was made by Commissioner Gordon Wilder to accept the FY 2012-13 Audit Report as presented. This motion was seconded by Commissioner Thomas S. Hester, Jr. and unanimously approved.

Public comments were heard next. As a result of the Commissioners' Planning Retreat, Mr. Michael Bobbitt offered three suggestions to the Board as follows: 1. Add an appointment to the Commissioners' Board agenda from March to December to allow individuals the opportunity to make presentations for growing the local economy. During the next planning retreat, the Board could establish plans based on the public's presentations. 2. Before authorizing the clearing of vacant buildings, consider including a zoning restriction prohibiting construction of government subsidized housing on the cleared properties. 3. Post a quarterly financial report to the County's website.

Water District Board

At this time, Chairperson Deborah F. Brown called the Water District Board to order.

Budget Amendment. Finance Director David C. Beck explained that a budget amendment is needed to amend the water fund operating budget to reflect most recent projections based on Phase 1A being turned on during the current fiscal year.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Eddie L. Wright, vote unanimous, to approve the following budget amendment as presented:

Purpose: To amend the Water Fund operating budget to reflect most recent projections based on Phase 1A being turned on during the current fiscal year.

Authorization: Vance County Board of Commissioners February 3, 2014

Change Orders. Mr. Jordan McMillen, Deputy County Manager and Director of Planning and Development provided the following overview for Phase 1A Change Orders.

- Road Additions. As construction continues to wrap up for Phase 1A, staff has been working with the Engineer (Hobbs Upchurch) and the Contractor (H.G. Reynolds) to prepare a second group of road additions. Previously, this second group was held back as they needed to be designed and permitted. The finalized plans for a total of eight road additions were submitted to the State on December 20, 2013. Approval of these permits is anticipated within the next 30 days. These roads are as follows: Contract 1, Changer Order #5 (Abbeys Lane) - \$25,559.60; Contract 2, Change Order #4 (Stevenson's MHP, Hamp Falkner Road, Village Drive, Kitts Landing MHP, Tower Road Extension, Aycock Road Extension, and Cheatham Mabry Road. Mr. McMillen noted that Cheatham Mabry Road is being pulled from the group of roads in order to be studied more closely over the next month. The operation and maintenance costs may not justify the installation costs. The amount of the change order is \$294,502.70.

Commissioner Archie B. Taylor, Jr. asked for comparative numbers on installing the water lines versus the maintenance costs of those water lines.

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to approve Change Order #5 for Contract 1 in the amount of \$25,559.60 for the addition of Abbeys Lane.

Motion was made by Commissioner Eddie L. Wright, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to approve Change Order #4 for Contract 2 in the amount of \$294,502.70.

- Booster Pump. Mr. McMillen stated that plans have been submitted to the State for installation of a booster pump at the Phase 1A water tank. Approval of this change order

(Contract 1, Change Order #6 in the amount of \$59,331.59) will allow this work to commence subject to plan approval by the State.

Motion was made by Commissioner Thomas S. Hester, Jr. to approve Change Order #6 for Contract 1 in the amount of \$59,331.59 for the installation of a booster pump at the Phase 1A water tank. This is contingent upon the plan being approved by the State. This motion was seconded by Commissioner Archie B. Taylor, Jr. and unanimously approved.

- Water Tank Pressure Sensing Line. Mr. McMillen stated that a change order is needed for Contract 4 in the amount of \$4,986.40 for work providing a pressure sensing line from the outlet of the tank to the altitude valve.

Commissioner Dan Brummitt asked why this wasn't included in the original bid and is it included in Phase 2. David Townsend, Hobbs Upchurch, responded that it was an oversight that it was not included in Phase 1A. It is included in Phase 2.

Motion was made by Commissioner Thomas S. Hester, Jr. to approve Change Order #4 for Contract 4 in the amount of \$4,986.40 for work providing a pressure sensing line from the outlet of the tank to the altitude valve. This motion was seconded by Commissioner Archie B. Taylor, Jr. and unanimously approved.

Estimated Design and Inspections for 1st and 2nd Group of Road Additions. Mr. McMillen explained that based upon the submitted construction costs for all road additions to date, the USDA fee curve was used to estimate design and inspection costs as a result of adding a total of 15 roads. This additional fee is estimated to be \$119,458. The actual value of this work is contingent upon the amount of time needed for inspections on site, but approval of this estimate to be taken from Contingency funds will provide a clearer picture of the current budget.

The Board decided to table this matter until the March meeting.

Mr. Tim Carpenter, LKC Engineering, provided an update on Phases 2A and 2B. He stated that progress is going very well and four miles of pipe have been installed to date. The tank contractor will be on site in the next two weeks to begin clearing of the lot and pouring foundations. Mr. Jordan McMillen stated that door hangers are being hung just prior to construction and there has been an increase in sign-ups since construction began. Two community meetings have been scheduled for Phase 1A and three meetings have been scheduled for Phase 2. Letters and brochures will be sent out to residents in advance of these meetings as well as a phone call to the residents.

Commissioner Dan Brummitt asked that the Water Planning Committee review the brochure before it is mailed out.

At this time, Chairperson Brown adjourned the Water District Board.

Vance-Warren Opportunities, Inc. and Vance County have executed the agreement for the five Neighborhood Stabilization Program (NSP) houses as approved by the Board of County Commissioners for transfer of ownership for rental to NSP-eligible tenants. The contractor is currently repairing vandalism damage to the five houses, immediately after which ownership of the five properties will be transferred to FVW. According to FVW, NSP-eligible tenants have now been enlisted for all the five rental houses.

The Committee discussed the needed process to successfully sell the six remaining NSP houses. The County Attorney has met with local real estate agent, Tonya Hester, Century 21 Hancock Properties, to pursue the specialized marketing and sale of the remaining houses. The County Attorney believes engaging Mrs. Hester's services would be a good step in meeting the schedule that the State has established for sale of the houses. The Committee was in full agreement in making the following recommendation to the Board of Commissioners: authorize the Planning and Environmental Committee to engage Tonya Hester, Century 21 Hancock Properties, on behalf of the Board of the Vance County Commissioners as the listing agent for the remaining six Neighborhood Stabilization Properties.

Semi-Annual Jail Inspection Report. Mr. Ayscue noted that the NC Division of Health Service Regulation, Construction Section, conducts inspection of county detention facilities twice a year. The Vance County Jail was inspected on December 31, 2013. A plan for corrective action must be submitted by February 7, 2014. He recommended that the Board accept the December 31, 2013 Vance County Jail Inspection Report for informational purposes.

Established Objectives. The Board of Commissioners established several objectives for FY 2014-15 during its annual planning retreat as follows:

- Improve affordability of county water by increasing the number of customers in Phase 1A by 5% by the end of FY 2015.
- Improve affordability of county water by increasing the number of customers in Phases 2A and 2B by 35% by the end of FY 2015.
- Grow local economy through small businesses by planning for the establishment of a redevelopment authority or other similar entity for the purpose of creating jobs, expanding the County's tax base, and breathing new life into neighborhoods and business districts.
- Reduce the number of vacant, county owned buildings by 67% by the end of FY 2015.
- Develop a three-year action plan for constructing a new animal shelter in coordination with the Animal Control Advisory Committee, and acquire the neighboring property from the State of NC during FY 2014-15.

It was noted that during the Planning Retreat, the objective to grow the local economy was referred to the Planning and Environmental Committee to be re-worded. Mr. Ayscue recommended that the Board approve the other four objectives at this time. The fifth objective will be brought back to the Board during its March meeting.

Motion was made by Commissioner Dan Brummitt to approve objectives #1, #2, #4, and #5 as developed by the Board of Commissioners for FY 2014-15. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

The Board directed the staff to provide a timeline on these objectives. Mr. Ayscue stated that a timeline would be provided as well as a monthly progress report on these objectives.

Disposition of Surplus Equipment. Mr. Ayscue provided a list of surplus equipment for proper disposition. Items which have salvage value will be offered for sale or made available to eligible organizations according to the General Statutes by the Finance Director after the Board of Commissioners has declared it as surplus.
