COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, November 5 at 6:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairman Terry E. Garrison, Commissioners Thomas S. Hester, Jr., Deborah F. Brown, Dan Brummitt, J. Timothy Pegram, Gordon Wilder and Eddie L. Wright.

Absent: None.

Also present were County Manager Jerry L. Ayscue, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Commissioner Dan Brummitt gave the invocation.

Karen Foster, Council of Governments, was first on the agenda to present bid tabulations for the CDBG Community Revitalization Project – Julia Avenue, as follows:

Pending verification of licensing, insurance, and references, Ms. Foster recommended that the bids be awarded in the following manner:

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to approve the bids as presented pending verification of licensing, insurance, and references.

Ms. Foster stated that there are still six homes on Julia Avenue that need to be bid out and approved. She asked the Board to consider calling a special meeting before the regular December

meeting in order to award these bids. Commissioner Deborah F. Brown asked if the County Manager could be authorized to approve these bids on behalf of the Board rather than hold a special meeting. The bids would be approved on a low bid basis. County Attorney Jonathan S. Care stated that the Board does have the authority to do this.

Motion was made by Commissioner Deborah F. Brown to authorize the County Manager to approve any low bids for CDBG that may surface from now until the December regular meeting. Any approved bids would be reported to the Board during its next regular meeting. This motion was seconded by Commissioner Thomas S. Hester, Jr. and unanimously approved.

Ms. Foster updated the Board on the Stagecoach Road project. She stated that the homeowner has signed all legal documents and is ready to move forward. References were made available to the County Manager for review and the contract is ready to be signed. The Board thanked Ms. Foster for this update.

Ms. Porcha Brooks, Tax Administrator, was next on the agenda and presented an appeal on a late listing penalty for Dish Network LLC. Dish Network is appealing the late listing penalty for tax years 2007-2012 business personal property. Ms. Brooks explained that the appellant has asked for an appeal due to a discovery of business personal property by Evans and Associates. The appellant is appealing the penalty amount of \$912. Dish Network LLC states that the issue of discovered property is centered around their reporting of property based on cost less an adjustment factor for intangibles, shrinkage, and a reverse cost trending. Ms. Brooks recommended that the penalty stand according to NCGS 105-312(h).

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Eddie L. Wright, vote unanimous, to support the tax administrator's recommendation not to waive the \$912 penalty against Dish Network LLC.

Ms. Brooks then presented an appeal on an untimely present-use application from James T. and Cheryl A. Ellington; and Brian A. and April H. Ellington. The appellants failed to apply for the Present-Use Value Program in the month of January; therefore, the assessor is unable to approve the 2012 untimely application that was submitted on August 20, 2012. It must be approved by the Board of Commissioners. Ms. Brooks advised that if the application had been submitted on time, it would have been approved.

After a brief discussion, motion was made by Commissioner Dan Brummitt to approve the application and approve the property as farm use as intended. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

At this time, Chairman Garrison introduced Ms. Linda Fry as the new Director of Social Services. The Board officially welcomed Ms. Fry to Vance County. Ms. Fry provided a brief summary of her background and thanked the Board for this opportunity. She stated that she looks forward to what is ahead for Social Services.

As advertised, at 6:30 p.m., a public hearing was held to gain citizen input on the Solid Waste Plan Update. Mr. Jordan McMillen, Planning Director stated that local governments are required to plan for solid waste management. This planning takes place by way of a 10 year solid waste plan which must undergo a mandatory revision every three years. The implementation of the Vance County Comprehensive Solid Waste Management Plan and the three year updates provide Vance County Management with a plan for reducing the waste stream over the next 10 years, with revised updates every three years. The planning area includes Vance County, the City of Henderson, the Town of Kittrell and the Town of Middleburg. Mr. McMillen then provided an overview of the Plan highlights and goals.

Commissioner Dan Brummitt questioned if the County was paying tonnage weight for hauling recyclables. County Manager Jerry L. Ayscue stated that we do not pay hauling fees on this. Commissioner Brummitt suggested that an investigation be done on this matter because it seems that this is a potential revenue stream that the County may be missing.

Commissioner Brummitt questioned when contract negotiations will begin for hauling solid waste to the area landfill. He noted that Granville County has just opened a new landfill and has expressed interest in Vance County using that facility. This would be less expensive than the current arrangement of transferring waste to Person County. Mr. Ayscue stated that negotiations should begin in the next year. Commissioner Brummitt stated that during recent budget deliberations, the Board had asked for hauling costs to be reviewed, but this has yet to be done. He asked that this be attended to.

Commissioners Brown and Brummitt discussed the operations of the convenience sites and the fact that residents from other counties are using Vance County sites. This needs to be addressed in order to cut tonnage costs.

At this time, Chairman Garrison interceded and asked Mr. McMillen what action is needed from the Board. Mr. McMillen responded that while these are valid issues that may need to be addressed, they are not part of the Solid Waste Plan update. He asked the Board to approve the Plan update by resolution.

As there was no one else who wished to speak on the matter, Chairman Terry E. Garrison declared the public hearing closed.

Motion was made by Commissioner Thomas S. Hester, Jr. to approve the Solid Waste Plan update by resolution as presented. This motion was seconded by Commissioner Eddie L. Wright.

Commissioner Dan Brummitt noted the last statement of the resolution states that the Board accepts and endorses the Plan update. He stated that he cannot support the Plan in its current state considering the issues that were just raised.

Mr. Ayscue stated that Commissioner Brummitt’s concerns, while valid, are operational in nature. The Solid Waste Plan doesn’t get into the mechanics of operations. Approval of the Plan does not preclude the County from addressing those issues. Mr. McMillen advised that the County’s separate Waste Disposal Plan would be the appropriate place to address these operational matters.

Commissioner Deborah F. Brown asked that the Solid Waste Plan and the Waste Disposal Plan be used to support review of the concerns raised. She also suggested that the Plans be made available to Waste Industries.

Chairman Garrison directed the Planning/Environmental Committee to review these concerns further and have a recommendation available to the Board before next year’s budget deliberations.

Vote on the motion to approve the Solid Waste Plan update by resolution was ayes – six (6); noes – one (1), with the dissenting vote being cast by Commissioner Dan Brummitt.

Solid Waste Management Plan Three-Year Update

WHEREAS, it is a priority of Vance County to protect human health and the environment through safe and effective management of municipal solid waste; and

WHEREAS, the reduction of the amount and toxicity of the local waste stream is a goal of this community; and

WHEREAS, equitable and efficient delivery of solid waste management services is an essential characteristic of the local solid waste management system; and

WHEREAS, it is a goal of the community to maintain and improve its physical appearance and to reduce the adverse effects of illegal disposal and littering; and

WHEREAS, Vance County recognizes its role in the encouragement of recycling markets by purchasing recycled products when feasible; and

WHEREAS, involvement and education of the citizenry is critical to the establishment of an effective local solid waste program; and

WHEREAS, the State of North Carolina has placed planning responsibility on local government for the management of solid waste; and

WHEREAS, NC General Statute 130A-309.09A(b) requires each unit of local government, either individually or in cooperation with other units of local government, to update the Ten Year Comprehensive Solid Waste Management Plan at least every three years; and

WHEREAS, Vance County has undertaken and completed a planning effort to evaluate the appropriate technologies and strategies available to manage solid waste effectively;

NOW THEREFORE BE IT RESOLVED, by the Vance County Board of Commissioners that the 2012 – 2022 ten year comprehensive solid waste management plan is accepted and endorsed and will be placed on file with the Clerk to the Board.

Mr. Paul McKenzie, Cooperative Extension, was next on the agenda and requested authorization to proceed with construction bids for the farmers market project. He explained that grant funding has been secured from the NC Tobacco Trust Fund Commission 2011, the NC Ag Development and Farmland Preservation Trust Fund, and the NC Tobacco Trust Fund Commission 2012 for a total amount of \$500,000. Of that, approximately \$15,000 has been used for site planning.

The original design of the building was for 18 vendor spaces, but rough estimates indicate that the current budget will not allow for construction of this size. Mr. McKenzie stated that staff proposes soliciting bids for a structure with 14 vendor spaces. If bids come in over budget, options to scale back the design can be considered. The building design will allow for reduction

or expansion of vendor spaces, depending on funding. Commissioner Dan Brummitt stated that an amended operational budget needs to be developed based on the reduction of vendor spaces.

County Manager Jerry L. Ayscue stated that the intent is not to build a smaller facility. The intent is to construct a facility based on the original design of 18 vendor spaces, but this may need to be done in phases as grant funds are secured.

Mr. McKenzie advised that the facility will also be designed for community use such as meetings, events, etc. The Farmers Market Advisory Committee has discussed this matter and will recommend policies and procedures for renting the facility.

After further discussion, motion was made by Commissioner Thomas S. Hester, Jr. to authorize the staff to proceed with solicitation of construction bids for the farmers market project with the understanding that the Farmers Market Advisory Committee comes back with proposed operating costs. This motion was seconded by Commissioner Deborah F. Brown and unanimously approved.

Public comments were heard next. Ms. Seneca Nicholson spoke regarding the Community Development Block Grant for the Flint Hill area and funding to be used for this project. Chairman Garrison informed Ms. Nicholson that this funding has been solicited by the City of Henderson rather than the County of Vance. Ms. Nicholson apologized for the inconvenience and stated that she would go to the City Council.

At this time, Chairman Garrison recognized Commissioner J. Timothy Pegram and noted that this is his final official Board meeting. He personally thanked Commissioner Pegram for his leadership, guidance, and mentoring during his years of service. Commissioner Pegram stated that 48 years is a long time and he has enjoyed every one of those years. He thanked everyone that has kept him on the Board for so many years. Commissioner Hester stated that Commissioner Pegram's many years of service shows a tremendous commitment to this community and the citizens of this county. Commissioner Brown stated that Commissioner Pegram has been her mentor over the years and will always be her "favorite" commissioner. Commissioner Wilder expressed his admiration of Commissioner Pegram's integrity over the years and thanked him for all that he has done for this county. Commissioner Eddie L. Wright stated that Mr. Pegram is a man of his word and wished him well during his upcoming retirement. Commissioner Brummitt stated that Commissioner Pegram was a commissioner before he was born! He thanked Commissioner Pegram for his insight on issues during the past few years and

wished him happiness during his retirement. Commissioner Pegram received a standing ovation from the Board and citizens that were present at the meeting.

Motion was made by Commissioner Eddie L. Wright, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to approve the position requests as presented.

Public Safety Committee. Mr. Ayscue reported that this committee met at the County Fire and EMS Station on Tuesday, October 22 to review a request from the Fire and EMS Department for repair funds for the station and one of the fire trucks. Efforts are currently in progress to obtain quotes from appropriate contractors on having the work done. Once the quotes are obtained, a recommendation from the committee will be made to the full Board.

County Manager's Report

Resolution Approving Financing Terms. Mr. Ayscue noted that the Board of County Commissioners previously approved the purchase of radio consoles for 911 Emergency Communications. Quotes for financing the project were obtained and Branch Banking and Trust Company (BB&T) was the lowest. The project cost is \$196,565 which will be financed for five years at an annual interest rate not to exceed 1.77%. Funds are available in the Emergency Telephone Surcharge Fund. He requested adoption of a resolution approving the financing terms as indicated.

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Deborah F. Brown, vote unanimous, to adopt the following resolution approving financing terms for radio consoles.

WHEREAS, Vance County, North Carolina (the “County”) has previously determined to undertake a project for Radio Consoles (the “Project”), and the Finance Officer has now presented a proposal for the financing of such Project.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. The County hereby determines to finance the Project through Branch Banking and Trust Company (BB&T), in accordance with the proposal dated September 28, 2012. The amount financed shall not exceed \$196,565.00, the annual interest rate (in the absence of default or change in tax status) shall not exceed 1.77%, and the financing term shall not exceed five (5) years from closing.
2. All financing contracts and all related documents for the closing of the financing (the Financing Documents) shall be consistent with the foregoing terms. All officers and employees of the County are hereby authorized and directed to execute and deliver any Financing Documents, and to take all such further action as they may consider necessary or desirable, to carry out the financing of the Project as contemplated by the proposal and this resolution. The Financing Documents shall include a Financing Agreement as BB&T may request.
3. The Finance Officer is hereby authorized and directed to hold executed copies of the Financing Documents until the conditions for the delivery of the Financing Documents have been completed to such officer’s satisfaction. The Finance Officer is authorized to approve changes to any Financing Documents previously signed by County officers or employees, provided that such changes shall not substantially alter the intent of such documents or certificates from the intent expressed in the forms executed by such officers. The Financing Documents shall be in such final forms as the Finance Officer shall approve, with the Finance Officer’s release of any Financing Document for delivery constituting conclusive evidence of such officer’s final approval of the Document’s final form.
4. The County shall not take or omit to take any action the taking or omission of which will cause its interest payments on this financing to be includable in the gross income for federal income tax purposes of the registered owners of the interest payment obligations. The County hereby designates its obligations to make principal and interest payments under the Financing Documents as Qualified tax-exempt obligations for the purpose of Internal Revenue Code Section 265(b)(3).
5. The County intends that the adoption of this resolution will be a declaration of the County’s official intent to reimburse expenditures for the project that is to be financed from the proceeds of the BB&T financing described above. The County intends that funds that have been advanced, or that may be advanced, from the County’s general fund, or any other County fund related to the project, for project costs may be reimbursed from the financing proceeds.
6. All prior actions of County officers in the furtherance of the purposes of this resolution are hereby ratified, approved and confirmed. All other resolutions (or parts thereof) in conflict with this resolution are hereby repealed, to the extent of the conflict. This resolution shall take effect immediately.

Register of Deeds - Records Retention and Disposition Schedule. Mr. Ayscue explained that the State has issued a newly updated Records Retention and Disposition Schedule for Registers of Deeds. Upon adoption, it will automatically supersede the 2003 version and the amendment made in 2004. Vance County Register of Deeds Carolyn Pecora requests that the Board of Commissioners approve this new schedule for her office.

Motion was made by Commissioner Thomas S. Hester, Jr. to approve the 2012 Register of Deeds Records Retention and Disposition Schedule for Vance County. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Surplus Property. Mr. Ayscue reported that the Department of Social Services has several items to be determined as surplus. They are as follows:

Motion was made by Commissioner Eddie L. Wright, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to declare the items as presented as surplus property and authorize the Finance Director to proceed with public sale in a manner consistent with legal requirements.

Schools - Capital Outlay Itemization. Mr. Ayscue stated that consistent with prior years, the County has not remitted FY 2012-13 capital outlay funding to the Public Schools until an approved itemization of projected expenditures is received. The Board of Education approved the capital outlay budget on October 8, 2012 that was enclosed in the agenda material. Upon approval, the County will forward the appropriate funding to the Schools.

Motion was made by Commissioner Eddie L. Wright to approve the itemized listing of capital outlay expenditures for the Vance County Schools System for FY 2012-2013. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

Commissioner Dan Brummitt requested a further breakdown of Category II – Custodial/Maintenance Equipment. Mr. Ayscue responded that he would get this listing to the Board as soon as possible.

Appointment of Interim Finance Director. Mr. Ayscue advised that with the recent resignation of Steve Stanton, the County must have an acting or interim finance officer (director). One option is to appoint the County Manager in that capacity until a permanent finance director is selected. He recommended the Board to appoint the County Manager as the Interim County Finance Director until a permanent director is employed.

Motion was made by Commissioner Thomas S. Hester, Jr. to appoint the County Manager as the Interim County Finance Director until a permanent director is employed. This motion was seconded by Commissioner Deborah F. Brown and unanimously approved.

Pending Business

County Water Project. County Manager Jerry L. Ayscue introduced Mr. Rob Bernard with Hobbs Upchurch and Associates who will be overseeing the County's water project. Mr. Bernard provided a brief update on Phase 2 of the water project. He recommended that advertising for contractors take place at the end of this month, with bids to be submitted in mid-January, and award of bids to take place in April. He noted that sign-up analyses for Phase 2A have been completed and numbers are sufficient to move forward.

Commissioner Dan Brummitt stated that in looking at the tap sign-up reports, there seem to be some sign-ups on Foster Road that should be served by the Kittrell system. Chairman Garrison stated that Foster Road is a substantial part of the Sandy Creek Township and should be served by Phase 1A, not Phase 1B (Kittrell). Mr. Bernard stated that he would research this matter.

In addition to Mr. Bernard's update, Mr. Ayscue reported that Phase 1A construction work began on July 9. During October, an additional 28 sign-ups were received. As of the end of October, a total of 796 customers have been enrolled, and there are 14 additional dry taps. Site preparation work has begun at the tank site along Warrenton Road. Line construction continues along Brookston and Vicksboro Roads as well as other areas. The rate of construction has been slowed recently by rock that has been encountered on several roads. It is anticipated that construction of tank supports will begin later this month. Monthly construction meetings are held to coordinate on various issues with construction, safety, billing, traffic control, etc. *Phase 1B.* USDA Rural Development and Kittrell Water Association continue to work together to seek funding for Phase 1B, consistent with action taken by the Commissioners in December 2009. *Phases 2A & 2B.* Funding from USDA Rural Development has been established for both of these phases. Phase 2A will be funded with \$2.2 million in loans and \$1.62 million in grants. Phase 2B has \$3.94 million in loans and \$1.99 million in grants. The Board of County Commissioners and the Water District Board approved the water purchase/sales agreement with the City of Henderson on July 23, 2012. USDA Rural Development subsequently approved the agreement. USDA Rural Development has been notified that the ARRA funds must be spent on an accelerated schedule with construction beginning by September 30, 2012, unless a waiver is obtained. This

represents a three-year difference in time (previously September 30, 2015). An extension (waiver) request regarding the deadline was submitted to USDA Rural Development to ensure that the project can be appropriately completed in the Spring. District and state USDA RD officials are highly supportive of granting an extension, but the final decision is to be made at the federal level. Thus far, the County has not received notification of waiver approval. The local and state USDA RD staff encourage the County to continue to proceed as expeditiously as possible. Project design is complete and has been submitted to the appropriate regulatory agencies. The City of Henderson, USDA RD, and the County's engineers are currently reviewing the project plans. Public Water Supply Section of DENR has provided approval of the project. Permit applications are pending with Erosion and Sedimentation Control. Requests for approval of encroachment agreements were submitted to NCDOT in September. Submission of application information to USDA Rural Development is currently being done for both phases. A site for the water tank and one meter vault in the area covered by Phase 2A and 2B is now going through the appropriate approval process with the Schools System for a 99-year lease. Negotiations have taken place with two additional property owners for two meter vault sites and approval of the Water District Board will be sought later during this meeting. The engineers are reviewing a possible lake crossing permit. There are some low pressures concerns in the Poplar Creek Road area that are being studied and addressed. Due to the timing of the funding of Phases 2A & 2B, it will be important that work on these phases begin as soon as possible. The approved O&M services contract will cover Phases 2A and 2B in addition to 1A. Additional sign-ups remain essential in Phases 2A and 2B due to the current lack of substantial customer concentration. The engineering firm is working on a sign-up analysis of both phases. Current sign-up totals are 359 for Phase 2A and 359 for Phase 2B.

Volunteer Fire Department Contracts and Audits. Mr. Ayscue reported that all contracts have been received. One of the three audit reports that were due October 31 has been received by Townsville VFD. Drewry and Epsom have not yet been received. Mr. Ayscue stated that Drewry's audit is currently in the hands of their auditor, but the final report is not yet ready. He requested that Drewry not be penalized due to this fact. Fire Chief Harold Henrich was asked to notify Epsom VFD regarding their audit report, but we have not yet heard back from him.

Chairman Garrison requested that each volunteer fire department notify the County who their auditor is. Also, he asked that each volunteer fire department obtain a statement from their

auditor or give the County authorization to obtain a statement from their auditor as to the progress of their audit report.

Consent Agenda

Commissioner Dan Brummitt questioned the many Tax Refunds and Releases that were categorized as “remove late listing penalty”. Tax Administrator Porcha Brooks was present and stated that this was the correction of a staff error.

Ms. Brooks then responded to the refund that was questioned during last month’s meeting. She advised that this was a double listing that needed to be corrected.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Deborah F. Brown, vote unanimous, to approve the following consent agenda items: Budget Amendments #5 - #7, September 2012 Tax Refunds and Releases, October 2012 Monthly Reports received and filed, and the minutes of the October 1, 2012 regular meeting.
