## COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, October 3, 2022 at 6:00 p.m. in the commissioners' conference room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those commissioners present were as follows: Chairman Leo Kelly, Jr., Vice-Chair Yolanda J. Feimster, Commissioners R. Dan Brummitt, Carolyn Faines, Thomas S. Hester, Jr., Archie B. Taylor, Jr., and Gordon Wilder. Absent: None.

Also present were County Manager Jordan McMillen, Finance Director Katherine Bigelow, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Associate Pastor Mary Anderson, Shiloh Baptist Church, gave the invocation.

The first item on the agenda was a presentation from Senator Lisa Barnes. She presented a check in the amount of \$500,000 from the State of North Carolina to be used towards construction of the shell building at the Henderson-Vance Industrial Park. The board thanked her for her help in getting funding in the approved state budget to assist with this project.

Mr. Frankie Nobles, Vance County Employee Engagement Team Chair, was next on the agenda to recognize the new employee of the month. He noted that employees are nominated by their peers, and this month's recognition goes to Nate Dumas with Vance County Information Technology. His peers noted that he comes to work each day with a positive attitude, is a team player, and is always willing to help others as needed. Mr. Dumas will receive a \$100 gift card and a designated parking space for the month. He was presented a certificate of appreciation, and the board congratulated him on receiving this recognition.

Economic Development Director McKinley Perkinson appeared before the board and noted that one of the board's goals for the year was to complete an Economic Development Strategic Plan. She stated that a strategic planning sub-committee of the EDC Board was formed, and RFPs were solicited for the development of a strategic plan. Seven responses were received and reviewed by the committee. The EDC Board's recommendation is to award the contract to Creative Economic Development Consulting for the completion of an economic development strategic plan. Motion was made by Commissioner Dan Brummitt to award the contract to Creative Economic Development Consulting for the completion of an economic development strategic plan. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

# Water District Board

Chairman Leo Kelly, Jr. called the Water District Board to order, and the August 2022 monthly operations report was presented to the board for information. County Manager Jordan McMillen informed the board that 41 signups were received during the recent signup campaign that ran in August and September. He also noted that Envirolink has expanded its local office hours to Monday through Friday from 9:00 a.m. to 1:00 p.m.

Chairman Leo Kelly, Jr. adjourned the Water District Board.

#### Committee Reports and Recommendations

Technology Committee – Courtroom Audio Visual Experience (CRAVE)/Wireless Access for Virtual Enhancement (WAVE) Projects. County Manager Jordan McMillen reported that the committee (Brummitt, Feimster & Taylor) met Tuesday, September 27 with county staff and Clerk of Court Henry Gupton to discuss a project to add audio, visual and wireless access for two of the three courtrooms and administrative office of the courts/state offices at the courthouse. This project is a part of the NC Administrative Office of the Courts' efforts to upgrade capabilities to safely and securely hold remote court proceedings across all counties in North Carolina. The committee was made aware that the state intends to cover the cost for all audio-visual equipment and future maintenance/replacement costs which includes HD monitors, cameras, and audio devices for attorneys, judges, and witness stands. Counties are responsible for the wiring infrastructure that is a part of the physical structure of the courthouse. He stated that the total County cost is approximately \$27,426 which is estimated at \$8,613 per courtroom (CRAVE) plus \$10,200 for the wiring to provide wireless (WAVE) to courtrooms and AOC office/public areas within the courthouse. Staff recommended utilizing existing funds within the county's facilities fees fund to complete the project. The committee questioned why the third courtroom (district courtroom) was not included and learned the state only approved two courtrooms at the current time. He noted that the committee requested that staff look into options and potential solutions for adding remote capabilities within the third courtroom with concurrence by the state. The committee recognized the importance of proceeding forward to assist with remote hearings and made note that this system would reduce or eliminate a cost of \$9,000 per year that the county is

paying for the current audio/visual system in the courtrooms. He stated that the committee's recommendation is to authorize the county manager to execute the memorandum of agreement with NCAOC and the agreement with Presidio to proceed forward with the wiring necessary for the state's CRAVE and WAVE projects to upgrade courtroom audio, visual, and wireless equipment at the courthouse and approve Budget Amendment #18 providing up to \$30,000 from the facilities fund for completion of the project.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Gordon Wilder, vote unanimous, to authorize the county manager to execute the memorandum of agreement with NCAOC and the agreement with Presidio to proceed forward with wiring necessary for the state's CRAVE and WAVE projects to upgrade courtroom audio, visual, and wireless equipment at the courthouse and approve Budget Amendment #18 providing up to \$30,000 from the facilities fund for completion of the project.

*Human Resources Committee – Hiring Incentives*. Mr. McMillen noted that the committee (Faines, Taylor & Wilder) met today prior to the board meeting and discussed the most difficult to fill positions across the county. These positions, according to HR data, include Detention Officers, and Social Worker IAT and Social Worker III positions within the Child Protective Services unit at social services. The committee reviewed hiring incentive/sign-on bonus policies from

surrounding counties and discussed a proposed similar policy for Vance. He stated that the committee was in agreement and recommended proceeding forward with a hiring incentive/recruitment bonus policy that would provide \$500 after 30 days of employment, \$500 after six months of employment, \$1,500 after one year of employment, and \$2,500 after 24 months of employment for new employees within the three hardest to fill positions.

Motion was made by Commissioner Thomas S. Hester, Jr. to approve the Hiring Incentive Policy/Recruitment Bonus as presented. This motion was seconded by Commissioner Yolanda Feimster.

Commissioner Dan Brummitt stated that even after the salary study, we are already behind the market with detention officers' salaries. He noted that Nash County has started a new program and their detention officers' starting salary is \$40,168; senior officers with three years are \$45,882; and master officer with six years at \$52,765. He stated that this needs to be looked into further to make sure we don't fall even further behind.

Vote on the motion to approve the Hiring Incentive Policy/Recruitment Bonus as presented was unanimous.

#### County Manager's Report

Abandonment of Portion of NCDOT Roadway – Cardinal Drive. County Manager Jordan McMillen stated that the property owner at the end of Cardinal Drive (SR 1562) has requested DOT to abandon approximately 175 feet at the end of the roadway. The section to be abandoned is adjacent to the property of the individual requesting the abandonment and is being requested to counteract unwanted activity that has occurred in the area. An opportunity for public comments on this matter was provided at the September 6 meeting. Staff has followed up with NCDOT, and if the roadway maintenance is abandoned, they intend to convey ownership of the property which would allow the property owner to physically block access to the area of concern. Staff has followed up with the property owner and they believe this action is in the best interest of protecting their property.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Gordon Wilder, vote unanimous, to approve the following resolution requesting NCDOT to abandon a portion of Cardinal Drive (State Road 1562).

Jail Space and Facilities Needs Assessment. Mr. McMillen reported that staff recently received and reviewed request for qualifications (RFQs) that have been submitted from firms interested in providing the space and facilities needs assessment for the jail. The properties committee was previously involved in reviewing and supporting the RFQ and the board has previously taken action in support of moving forward with the study and to pay for the study from contingency funds. He noted that a total of three RFQs were received from the following firms: Justice Planners (Columbia, SC), Moseley Architects (Raleigh, NC), and TreanorHL (Alpharetta, GA). Upon reviewing the RFQs and with concurrence from the sheriff, staff recommends entering into negotiations with Moseley Architects for completion of the study. Moseley is not only based in North Carolina but appears to have the best understanding and familiarity with the county and has performed the vast majority of similar studies across the state the past several years including their leading of the Granville County jail project. The estimated completion time is 22 weeks or

five and a half months. Recommendation: Authorize the county manager to enter into negotiations with Moseley Architects and to finalize a contract with funding from contingency funds for completion of a space and facilities needs assessment for the jail.

Motion was made by Commissioner Gordon Wilder to authorize the county manager to enter into negotiations with Moseley Architects and to finalize a contract with funding from contingency funds for completion of a space and facilities needs assessment for the jail. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

*HVAC Replacement – Smart Start Building*. Mr. McMillen stated that the current budget and capital improvements plan includes \$56,000 to replace four of the five HVAC units at the smart start building located on Charles Rollins Road. The units to be replaced are 37 years old and are well beyond life. Staff has worked with Kilian Engineering for project design and bidding and recently took bids for the project. He noted that the lowest responsive, responsible bidder is Gupton Services at a total cost of \$71,745. He recommended awarding the contract to Gupton Services in an amount not to exceed \$71,745 and utilizing up to \$15,745 from fund balance to fill the gap in funding.

Motion was made by Commissioner Dan Brummitt to award the contract to Gupton Services, Inc. in an amount up to \$71,745 for replacement of four HVAC units at the smart start building and approve Budget Amendment #17 for the project. This motion was seconded by Commissioner Thomas S. Hester, Jr. and unanimously approved.

Sale of 350 Ruin Creek Road. Mr. McMillen noted that the board authorized staff to enter into negotiations with the YMCA and to develop an offer to purchase contract for selling the former DSS building and property located at 350 Ruin Creek Road. The building (19,684 square feet) and the land (2.46 acres) recently appraised for \$1,180,000 and the properties committee and board has previously discussed offers from both the YMCA and Vaya Health before deciding to enter further negotiations with the YMCA for selling the property. He noted that the YMCA has submitted an official offer to purchase totaling \$1,000,000 which includes conditions to ensure the property will be used for a public benefit which qualifies the property for private sale as per NCGS 160A-279. The YMCA would have six months from the purchase date to place the property into continuous use for a public purpose and the property must remain used for a public purpose for 10 years after the purchase date or the county would have the option to repurchase the property. Use of the property for programming, administration, storage or other uses supporting their current operations would allow them to comply with the public purpose provision. Mr. McMillen stated that the YMCA has not committed to a final use of the property and has heard varying opinions from architects as to whether they should rehab, reuse, tear down, and/or rebuild a building on the property. The YMCA intends to determine this as a part of the master planning and architectural study for their entire facility which includes using this property to meet future programming needs.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Gordon Wilder, vote unanimous, to approve the offer to purchase approving the sale of 350 Ruin Creek Road to the YMCA, subject to final attorney review.

#### Finance Director's Report

*Surplus Property*. Finance Director Katherine Bigelow stated that the Register of Deeds Office has a microfilm machine, a Richoh plat scanner/copier, and a microfilm plat reader that are no longer in use and parts for repair are not available. She requested that these items be declared as surplus.

Motion was made by Commissioner Dan Brummitt to declare the items as surplus and authorize the finance director to dispose of said property accordingly as allowed by state statute. This motion was seconded by Commissioner Carolyn Faines and unanimously approved.

#### County Attorney's Report

*REO Property – Bid Acceptance Resolution*. County Attorney Jonathan S. Care noted that during its March 2022 meeting, the board of commissioners approved the public sale process for

815 Water Street (Parcel 0069 04020). The property was advertised through the upset bid process and the bid was increased numerous times. The final bid is \$21,775. He stated that the board is now free to sell the property or reject the offer.

Appointments. The following appointments were presented to the board for consideration:

## <u>Vance County Appearance Commission – three year term</u> Reappoint Benny Finch, Barbara Richards, Rose Jarrell and Katherine Williamson

Motion was made by Commissioner Dan Brummitt to approve the reappointments as presented. This motion was seconded by Commissioner Carolyn Faines and unanimously approved.

At this time, motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Archie B. Taylor, Jr., vote unanimous, to enter into closed session to discuss a personnel matter.

Upon return to open session, motion was made by Commissioner Thomas S. Hester, Jr. to approve the minutes of the September 6, 2022 closed session. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

The board then discussed a salary increase for the county manager position. Chairman Leo Kelly, Jr. noted that the county manager position was not included in the recent salary study. He stated that he asked the HR Director to pull comparable salaries from surrounding counties and counties that are similar in size to Vance County. In doing so, it revealed that Vance County's salary is lower than all but one comparable county.

Commissioner Archie B. Taylor, Jr. stated that the HR Committee met this afternoon to review this matter. The committee discussed the fact that if the county manager position had been included in the salary study, the new salary would have been \$157,300. The committee recommended \$143,846.

Commissioner Carolyn Faines stated that all positions should have been included in the salary study and is in support of the increase.

Commissioner Dan Brummitt stated that he agrees an increase is in order but is concerned with the recommended amount.

Motion was made by Commissioner Archie B. Taylor, Jr. to increase the salary of the county manager position to \$143,846. This motion was seconded by Commissioner Thomas S.

Hester, Jr. and vote was ayes - six (6); noes - one (1), with the dissenting vote being cast by Commissioner Dan Brummitt.

As there was no further business, at 7:00 p.m., motion was made by Commissioner Gordon Wilder, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, that the meeting be adjourned.
