#### COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, October 6, 2014 at 6:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairperson Deborah F. Brown, Commissioners Archie B. Taylor, Jr., Dan Brummitt, Terry E. Garrison, Thomas S. Hester, Jr., and Gordon Wilder.

Absent: Commissioner Eddie L. Wright.

Also present were County Manager Jerry L. Ayscue, Finance Director David C. Beck, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Pastor Keith Benze, First Presbyterian Church, gave the invocation.

Before the first appointment, Chairperson Deborah F. Brown recognized Kelly Grissom, Clerk to the Board, who received the 2014 Outstanding Clerk Award from the Kerr-Tar Regional Council of Governments on September 25, 2014. She also recognized Jerry Ayscue, County Manager, who received the 2014 Regional Star Award from the Kerr-Tar Regional Council of Governments that same evening. The Board congratulated Ms. Grissom and Mr. Ayscue on receiving these awards.

Louvionetta Henderson. Motion was made by Commissioner Gordon Wilder to approve the exemption application as requested. This motion was seconded by Commissioner Archie B. Taylor, Jr. and unanimously approved.

Jessie Taylor. Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Gordon Wilder, vote unanimous, to approve the exemption application as requested.

Randall Joe and Faye G. Watkins. Motion was made by Commissioner Dan Brummitt to approve the exemption application as requested. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

As advertised, at 6:15 p.m., a public hearing was held to gain citizen input on the proposed Rural Operating Assistance Program (ROAP) application to be submitted to the North Carolina Department of Transportation no later than October 24, 2014 by the County of Vance. Finance Director David C. Beck explained that the programs included in the ROAP application are:

- 1. Elderly & Disabled Transportation Assistance Program (EDTAP) which provides operating assistance for the transportation of elderly and disabled citizens.
- 2. Employment Transportation Assistance Program (EMPL) provides operating assistance for the public transportation of persons with employment related transportation needs.
- 3. Rural General Public (RGP) Program provides operating assistance for the public transportation of persons living in non-urban areas of the county.

The amounts allocated are as follows: EDTAP - \$67,535; Employment - \$12,799; and Rural General Public - \$60,672 for a total of \$141,006 for the period July 1, 2014 through June 30, 2015.

As there was no one from the public who wished to speak on the matter, Chairperson Deborah F. Brown declared the public hearing closed.

Motion was made by Commissioner Gordon Wilder to approve the submission of the application for the Rural Operating Assistance Program and authorize the Chairperson, the County Manager, and the Finance Director to sign the certified statement. This motion was seconded by Commissioner Thomas S. Hester, Jr. and unanimously approved.

#### **Public Comments**

Mr. Michael Bobbitt stated that he had received an anonymous letter in the mail referencing an article that he had written on September 12<sup>th</sup> (either in the paper or Home in Henderson) on Fire and EMS costs rising. The letter asked, "how much money does the County get from private Medicare/Medicaid?" Mr. Bobbitt stated that he would like to know the answer to this question. The letter suggests that Bertie Transport take over the ambulance service and make Vance County Fire Department a volunteer department. Chairperson Brown asked the staff to respond to Mr. Bobbitt's question regarding private Medicare/Medicaid costs.

# County Manager's Report

Emergency Management – Vehicle Purchase. Mr. Ayscue noted that the Henderson-Vance County Emergency Operations Department annually receives an emergency management performance grant and has traditionally used these grants for replacement of response vehicles. Grants received in the past two years total \$29,745. Another grant is expected in March 2015 to total \$15,000 + as well. Brian Short, Emergency Operations Director, requests the replacement of a 10-year old Ford Expedition with a Ford F250 truck that will allow towing ability and storage for emergency management equipment and supplies. The projected cost of \$35,014 will be covered 100% by grant funds. Mr. Ayscue recommended that the Board approve the purchase of a 2015 F250 truck for emergency management at a cost of \$26,514, a camper shell for \$3,000, and up to \$5,500 for vehicle equipping, for a total cost not to exceed \$35,014. Funds are to come from emergency management performance grants.

Motion was made by Commissioner Thomas S. Hester, Jr. to approve the purchase of a 2015 F250 truck for emergency management at a cost of \$26,514, a camper shell for \$3,000, and up to \$5,500 for vehicle equipping, for a total cost not to exceed \$35,014. Funds are to come from emergency management performance grants. This motion was seconded by Commissioner Gordon Wilder.

Commissioner Dan Brummitt requested a breakdown/itemization of the \$5,500 for vehicle equipment. Mr. Ayscue stated that he would get this information to him. Commissioner Gordon Wilder asked how many miles were on the Ford Expedition. Mr. Ayscue responded that he did not know, but that he would get that information to him.

Vote on the motion was unanimous.

As advertised, at 6:30 p.m., a public hearing was held to gain citizen input on a rezoning request for 1410 Lynnbank Road (Cardinal Innovations Healthcare Solutions). Mr. Jordan McMillen, Deputy County Manager/Planning Director, stated that the request is to amend the zoning map to rezone one parcel (1.36 acres) from Office-Institutional (O-I) to Residential Low Density (R-30). The parcel was formerly a group living quarters which has been shut down and inactive for several years. The rezoning request is being made to allow the structure to serve as a single family dwelling, which is not permitted under the parcel's current zoning category. If the request is approved, the dwelling would need to be permitted with a conditional use permit under R-30, which is not permitted under O-I.

The Planning Board recommended approval of the request on September 11, 2014. The surrounding area is overwhelmingly residential and agricultural in nature, and the proposed amendment would make this parcel consistent with the allowable uses of surrounding properties. It would also align the county's rural and agriculture characteristics. Also, approval would allow the utilization of the property by attracting potential buyers of the property who wish to use it as a family dwelling.

As there was no one from the public who wished to speak on the matter, Chairperson Deborah F. Brown declared the public hearing closed.

Motion was made by Commissioner Thomas S. Hester, Jr. and seconded by Commissioner Gordon Wilder to approve the rezoning request for 1410 Lynnbank Road by the following rationale: the rezoning is consistent with the County's Land Use Plan by promoting productive reuse of an existing structure. Additionally, the rezoning will position the property to be zoned in a similar fashion to the surrounding area. Commissioner Dan Brummitt disclosed that he chairs the Cardinal Innovations local board. Vote on the motion was unanimous.

As advertised, at 6:40 p.m., a public hearing was held to gain citizen input on a rezoning request for 2041 Vicksboro Road (Frances Faye Wilson). Mr. Jordan McMillen, Deputy County Manager/Planning Director, stated that the request is to amend the zoning map to rezone one

parcel (50 acres) from Planned Manufactured Housing Community (R-R-H-C) to Agricultural

Residential (A-R). The parcel was formerly Max's Mobile Home Park. The mobile homes were

removed throughout the mid-2000s and there are currently two remaining structures on the

property. An approximate 75 ft. by 75 ft. family cemetery is located 435 feet from Vicksboro

Road. The rezoning request is being made to allow a large scale solar energy system (22.39

acres) to operate on the premises. If the rezoning is approved, the applicant will proceed with

the conditional use permit process with the Board of Adjustment. This is due to the fact that

solar farms are only permitted within the A-R zoning category with a conditional use permit.

The Planning Board recommended approval of the request on September 11, 2014 on the

basis that the rezoning would cause the property to be rezoned in a similar fashion to surrounding

property.

Mr. Greg Ness spoke on behalf of FLS Energy, Inc., the underlying applicant with Ms.

Frances Faye Wilson. He provided a brief background of FLS Energy, Inc. and spoke in support

of the rezoning request.

As there was no one else from the public who wished to speak in the matter, Chairperson

Deborah F. Brown closed the public hearing.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Gordon

Wilder, vote unanimous, to approve the rezoning request for 2041 Vicksboro Road by the

following rationale: the rezoning is reasonable and consistent with the County's Land Use Plan

by promoting the county's agricultural character. By approving the rezoning, the property would

be zoned similarly to the surrounding property and would be positioned for reuse.

Commissioner Dan Brummitt suggested that the Planning/Environmental Committee re-

visit the provisions for solar farms. Chairperson Brown agreed with this suggestion and directed

the staff to schedule such meeting and provide a report to the full board during the November

meeting.

There is also a position vacancy for a Lead Code Enforcement Officer. The Committee recommended that this position be held for now.

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Dan Brummitt, vote unanimous, to approve the position requests as presented.

Human Resources Committee - County Manager Search Process. The following items will be discussed in closed session: Review of questions for first round of interviews; Direction from the Board as to how they want to handle the review of applications, who will be on the initial and follow-up interview panels, and the selection of second interview questions.

Human Resources Committee - Creation of EMS Director Position. Mr. Ayscue stated that the committee was informed of the request from the Public Safety Committee for the HR Committee to consider establishment of an EMS Director position. The Public Safety Committee will continue to review the potential for establishing this position in the context of the Fire and EMS Study that was completed in 2008. No action by the Board is requested at this time. (See Public Safety Committee Report)

Human Resources Committee - Retirement Participation for Part-time Firefighter Positions. Mr. Ayscue explained that in order to continue the current arrangement of hiring part-time firefighters to staff two slots during the week at a VFD station in the north and south sections of the County and remain, it is necessary to begin paying retirement system contributions for these firefighters. Failure to do so will significantly reduce the number of available firefighters to staff these part-time slots. The anticipated cost is expected to not exceed \$9,100 annually and is projected to not exceed \$6,800 for the remainder of this current fiscal year. Committee Recommendation: Approve payment of retirement system contributions for part-time County-employed firefighters, effective October 1, 2014, with the funding to come from the Special Fire Tax Fund.

Motion was made by Commissioner Dan Brummitt to approve payment of retirement system contributions for part-time County-employed firefighters, effective October 1, 2014, with the funding to come from the Special Fire Tax Fund. This motion was seconded by Commissioner Gordon Wilder.

Commissioner Terry E. Garrison and Commissioner Archie B. Taylor, Jr. expressed their concerns with this matter in that they want to ensure that all County positions are treated equal, not just the fire department. After discussion, Chairperson Deborah F. Brown directed the staff to look at all other part-time positions within the county and provide a report to the full board during its November meeting. If not by the November meeting, by the end of the year.

Vote on the motion was unanimous.

Public Safety Committee - Creation of EMS Director Position. Mr. Ayscue reported that as requested by the Board of Commissioners, this committee met on Monday, September 15 to discuss matters related to filling the EMS Director/Fire Marshal position. The three Battalion Chiefs recommended that the County create a separate position of EMS Director and allow the current position to function as Fire Chief/Fire Marshal since the two functions of Fire and EMS have already been reorganized into separate divisions in the department. The two positions would be at the same organizational level and expected to work closely together to maintain essential interaction between the two departmental functions. Further, there would be a need for three additional positions to adequately staff the two functions. The Battalion Chiefs also expressed the need for staff for an additional ambulance per shift (6 additional positions) due to high volume of EMS calls.

Also requested was the provision of bullet-proof vests for EMS personnel as they respond in high risk situations. The Battalion Chiefs agreed to develop and implement internal policy prior to using the vests. The committee decided to recommend to the Human Resources Committee that it immediately consider the creation of an EMS Director position and review the need for adding other positions as appropriate in the future. Committee Recommendation: Appropriate \$14,000 from the Contingency for the purchase of 25 bullet-proof vests for County EMS personnel.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Gordon Wilder, vote unanimous, to appropriate \$14,000 from the Contingency for the purchase of 25 bullet-proof vests for County EMS personnel and approve Budget Transfer #3 as presented.

Purpose: For the purchase of 25 bulletproof vests to be used by EMS personnel.

Authorization: Vance County Board of Commissioners October 6, 2014

Commissioner Dan Brummitt noted that the committee requested the staff to review protocol when it comes to putting EMS personnel into high risk situations. Mr. Ayscue stated that the committee also requested staff to develop a protocol for the use of the vests.

General Government Committee. Mr. Ayscue noted that this committee was asked to consider a set of resolutions adopted by Surry County (resettling of illegal immigrants, including unaccompanied minors) and a separate resolution adopted by Henderson County (asking for the release of an American citizen held hostage in Mexico). The committee meeting was scheduled but had to be cancelled. However, the committee members individually reviewed the resolutions and are supportive of the Surry County resolutions but not the Henderson County resolution. Committee Recommendation: Adopt the four resolutions as presented.

Commissioner Terry E. Garrison stated that he cannot support adopting the resolutions. This is a federal matter, and Vance County should not get involved in telling other countries what to do. Commissioner Dan Brummitt agreed. After a brief discussion, the Board decided not to take action on the resolutions.

Planning & Environmental Committee. Mr. Ayscue stated that the Board of Commissioners directed this committee to review a request from Semprius, Inc. to extend a deadline for 18 months for its Building Reuse Grant (\$550,000) through the NC Rural Center (now handled by the NC Department of Commerce) and formulate a recommendation to the full

board. The committee met earlier today and conferenced Semprius CEO Joe Carr into the meeting by telephone. After discussion and review, the committee unanimously decided to recommend that the Building Reuse Grant 18-month extension be requested from the NC Department of Commerce.

Motion was made by Commissioner Gordon Wilder to approve the formal request from the County to the NC Department of Commerce for an 18-month extension of the existing Building Reuse Grant for the Semprius Project. This motion was seconded by Commissioner Terry E. Garrison and unanimously approved.

Chairperson Deborah F. Brown noted that she is still trying to get answers from Semprius as to how many Vance County residents are employed with Semprius.

#### Water District Board

Chairperson Deborah F. Brown called the Water District Board to order.

Water Planning Committee. Mr. Jordan McMillen, Deputy County Manager/Planning Director, reported that this committee met on October 1, 2014 and completed a review of the monthly construction and operations reports, and held a discussion in preparation for a meeting with city representatives regarding county waterlines in the Extra Territorial Jurisdiction (ETJ) and in close proximity to existing city waterlines. Additionally the committee held a closed session to discuss property and easement negotiation matters for Phase 2A and 2B.

Monthly Construction and Operations Reports (Phase 1A & 2A/2B). As requested by the full board, the committee has reviewed and fully discussed the reports with the engineers and Envirolink. The committee was made aware that construction is wrapping up in phases 2A and 2B with the potential for substantial completion of the originally bid lines within 30 days which will allow engineers to seek certification from the State to hook customers to the system. In reviewing the operational report, it was noted and discussed that customers are becoming acclimated to the system and have been more efficient with their water use and therefore the average water bill per customer has been reduced over the last few months from \$56.77 in June to \$51.66 in September. The committee stressed the importance of ensuring that the "availability" customers are paying their bills and have requested an aging report at their next meeting. In addition to these items, the committee was made aware that Envirolink will be providing an introduction and training presentation to the volunteer fire departments during the month of October. It is anticipated that the Departments have an interest in assisting with the

maintenance of fire hydrants including, determining the flow rates and painting the hydrants according to flow rates. The committee expressed a desire that any future painting of the hydrants should be carried out according to the industry standards. Further details on this will be brought to the committee as worked out with the volunteer fire departments.

Waterline Extensions in Close Proximity to Existing City of Henderson Waterlines. The committee reviewed the county and city water system maps and prepared for discussions with the City by determining potential areas where overlaps are apparent between the City and County water systems. Due to time constraints with the county funding, the committee focused their attention on areas within the existing water district boundaries and where existing signups have been obtained. As a result of these factors, the committee prioritized US 158 Business, West Woods Hills Subdivision (Weybossett Road), Carolina Pines Subdivision (Burning Tree Drive), Parrott Road and West Ridge Drive, Hicksboro Road to Dabney and Allen Roads and the private portion of Thomas Road within Phase 2. Within Phase 1 it is anticipated that remaining funds will be limited, however the committee has prioritized McNair Drive located off of Vanco Mill Road and NC 39 South, and have asked staff to analyze this area prior to meeting with the City. It is anticipated that a meeting will be set for the committee and city representatives in the next couple of weeks.

Chairperson Brown suggested that door-to-door campaigning be done in the New Hope, Townsville, and Tungsten Mine areas to encourage sign-ups. She stated that these areas are in a greater need for water than the private portion of Thomas Road. She also stated that it is not too late to do the right thing in regards to the \$30 base fee.

Closed Session – Property Matters. The committee met in a closed session to discuss property matters related to Phase 2A and 2B of the water system. The full Water District Board will discuss these matters further in closed session.

At this time, motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Gordon Wilder, vote unanimous, to enter into closed session to discuss property matters.

Upon return to regular session, motion was made by Commissioner Gordon Wilder to authorize the staff and county attorney to finalize an easement with Beatrice Moore in exchange for one dry tap at no cost along with an additional cash compensation of \$1,450. This motion

was seconded by Commissioner Thomas S. Hester, Jr. and vote was ayes - five (5); noes - one (1), with the dissenting vote being cast by Chairperson Deborah F. Brown.

Motion was made by Commissioner Thomas S. Hester, Jr. to authorize the staff and county attorney to finalize an easement with John and Barbara Foster in exchange for three dry taps at no cost. This motion was seconded by Commissioner Dan Brummitt and vote was ayes - five (5); noes - one (1), with the dissenting vote being cast by Chairperson Deborah F. Brown.

Motion was made by Commissioner Gordon Wilder to authorize the staff and county attorney to finalize an easement with Anthony and April Yarborough in exchange for a cash compensation of \$2,400 and any mulch derived from the tree cutting. This motion was seconded by Commissioner Thomas S. Hester, Jr. and vote was ayes - five (5); noes - one (1), with the dissenting vote being cast by Chairperson Deborah F. Brown.

Motion was made by Commissioner Thomas S. Hester, Jr. to authorize the staff and county attorney to finalize an easement with Timothy Jacobs and Lisa Jacobs Traflet in exchange for one dry tap at no cost. This motion was seconded by Commissioner Gordon Wilder and vote was ayes - five (5); noes - one (1), with the dissenting vote being cast by Chairperson Deborah F. Brown.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Gordon Wilder, vote unanimous, to adjourn the Water District Board.

At this time, motion was made by Commissioner Gordon Wilder, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to enter into closed session to discuss an economic development matter, personnel matters, and a real estate matter.

Upon return to open session, motion was made by Commissioner Gordon Wilder, seconded by Commissioner Dan Brummitt, vote unanimous, to accept the NC Department of Transportation's offer of \$2,920 for the purchase of a small piece of land in preparation for the replacement of the Hwy 39 bridge over I-85.

As there was no further business, at 9:10 p.m., motion was made by Commissioner Gordon Wilder, seconded by Commissioner Dan Brummitt, vote unanimous, that the meeting be adjourned.
