COUNTY OF VANCE

The Vance County Board of Commissioners met in special session on Thursday, May 24, 2012 at 5:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairman Terry E. Garrison, Commissioners Thomas S. Hester, Jr., Deborah F. Brown, Dan Brummitt, J. Timothy Pegram, Gordon Wilder and Eddie L. Wright.

Absent: None.

Also present were County Manager Jerry L. Ayscue, Finance Director Steven C. Stanton, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Chairman Terry E. Garrison gave the invocation.

The purpose of the special meeting was to receive the FY 2012-2013 Proposed Budget, schedule the budget hearing and budget work sessions, and approve a resolution in appreciation of Kay Fields.

*FY 2012-2013 Proposed Budget Estimate.* County Manager Jerry L. Ayscue presented the FY 2012-2013 Proposed Budget and stated that the General Fund budget is a "hold the line" budget based on current year expenditures. There is no ad valorem or fire tax increase proposed. The Solid Waste Household Fee is proposed to remain the same at \$105.00 annually. There is a reduced alliance on the fund balance appropriations in the amount of \$587,000. This compares to just over \$1.7 million that was budgeted last year. For the fourth year in a row, no funding is included for employee salary increases or the remaining portion of the salary study that was conducted in 2007. Mr. Ayscue stated that for the first time in his career, there is a decrease in the retirement matching rate. Health Insurance rates have also decreased slightly from last year.

After general discussion, motion was made by Commissioner Dan Brummitt to receive the FY 2012-2013 Proposed Budget. This motion was seconded by Commissioner Deborah F. Brown and unanimously approved.

*Budget Hearing.* Mr. Ayscue stated that it would be appropriate at this time to schedule the Budget Hearing. Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to schedule the Budget Hearing for the June 4, 2012 regular meeting at 6:15 p.m.

*Resolution of Appreciation.* Mr. Ayscue presented a Resolution of Appreciation on behalf of the Board of Commissioners to be presented to Mrs. Kay Fields upon her retirement.

Motion was made by Commissioner Deborah F. Brown, seconded by Commissioner Dan Brummitt, vote unanimous, to approve the following Resolution of Appreciation honoring Mrs. Kay Fields.
