Dear Sheriff Brame.

Thank you very much for the opportunity to represent you. I understand that you are retaining me to represent you related to a special proceedings summons related to the seizure of a car in Vance County. This representation is your individual/private capacity, not as an agent or employee of the Vance County Sheriff's Department.

I am pleased and appreciative that you have put your trust and confidence in me on this important matter. This letter sets out the proposed terms of our engagement. I will be the primary attorney in your matter. From time to time, in the interest of efficiency, I may also ask my legal assistant and my paralegal staff to assist me.

In charging for my services, I primarily consider the hours I spend on the matter and my hourly rate. My standard hourly rate on matters such as this is \$350 per hour. I will charge no higher than \$80 per hour for paralegal work work. You should not hesitate to contact me if you have any questions or concerns about our services.

I ask all new clients to deposit initial funds with my firm. I believe that an initial trust deposit of \$2500 is appropriate here. It is my standard practice to charge a true retainer, and \$1500 of these funds is a true retainer. This amount secures my representation of you in this matter. It is earned upon receipt. The remaining \$1000.00 will be refundable, and in the event the matter is resolved any portion of the \$1000.00 remaining after payment of time and expenses incurred will be refunded.

In the event the balance is depleted before the matter is resolved, we will request an additional retainer deposit, and/or will simply bill you on the standard hourly basis. My continued representation of you is expressly contingent upon timely payment of all legal fees.

We bill on a quarterly basis against your trust balance. We reserve the option of billing monthly if, in our discretion a monthly billing cycle is warranted due to increased demands of litigation. We will send you a statement for my legal services, out-of-pocket disbursements, and ancillary services during the preceding month(s). The statement you receive will contain a day-by-day summary of my legal services, indicating who rendered the services, and the time spent by each person on each day of service. Also, the statement will include an itemized description of any out-of-pocket costs we have advanced on your behalf. These advanced costs usually include travel expenses, filing fees, and third parties' invoices, such as court reporters' invoices. In addition, I will itemize charges for ancillary services I provide, such as terminal time for computer-assisted research, courier services, and photocopying.

You will at all times have the right to terminate my representation by giving notice to my firm. Any such termination will not, however, relieve you of the obligation to pay for all services I have performed and all expenses paid or incurred on your behalf before the termination.

To show that you have reviewed the above terms and agree with them, please sign the document below and return to me via email. I am also sending you a copy of this document with a request for electronic signature. If you sign it electronically, I will automatically be sent a copy. Please keep a copy for your files. Also, by your signature below, you are agreeing to receive invoices and payment information via text message. If you do not wish to receive text messages, please contact me directly to inform me of the same and we will communicate via phone, email and in person only.

Thank you again for the opportunity to serve you. It is my hope that our efforts will lead to a favorable resolution of this matter very soon.

Attorney Recommendation. Attorney Care stated that his role as county attorney has always been to provide civil and administrative legal guidance for the Sheriff's Office. He advised that he would like to take this opportunity to let the board know that it became apparent last week that a need has arisen for the Sheriff's Office to have legal guidance for criminal matters. He stated that the typical entity that has, in the past, provided this criminal legal guidance for the Sheriff's Office (District Attorney's Office) is no longer available due to adversarial reasons. He recommended that the board consider budgeting funds for the Sheriff's Office for criminal legal guidance. He noted that this would be for the entity of the Sheriff's Office related to criminal law, not criminal defense, of individuals or the Office. Commissioner Gordon Wilder asked if \$25,000 would be appropriate. Attorney Care responded yes, that amount would be appropriate.

Motion was made by Commissioner Gordon Wilder to appropriate \$25,000 from Fund Balance to support the Sheriff's Office in criminal matters and criminal operations of the Sheriff's Office, and not for individual criminal defense. This motion was seconded by Commissioner Leo Kelly, Jr.

During discussion, it was noted that this funding would be a recurring cost and the amount could vary if needed. It was also noted that if the district attorney's office changes in the future, it may not be needed at all. Commissioner Yolanda Feimster suggested that this funding be used solely for the purpose of criminal legal guidance and not transferred to another line item if legal guidance is not needed.

Vote on the motion to appropriate \$25,000 from Fund Balance to support the Sheriff's Office in criminal matters regarding the operations of the Sheriff's Office, and not for individual criminal defense was unanimous.


The current residential customer count is as follows:

## Vance County Water District Operations Report October 2024







# Committee Reports and Recommendations

## Vance County Committee Reports and Recommendations December 2, 2024

<u>Planning/Environmental Committee</u> The committee (Brummitt, Feimster & Taylor) met Thursday, November 7, 2024 to discuss the following agenda items:

Credit Accounts Landfill. The committee discussed the current practice in place that allows commercial customers to charge fees instead of paying at the time of service. To align the landfill's current practices with a credit account policy and ensure operational efficiency, staff and the County Attorney recommend creation of policy. Staff will continue to work with the County Attorney to develop a policy for presentation to the committee and then to the Commissioners for consideration. By formalizing and communicating these practices, the landfill can reduce financial risks, improve cash flow, and maintain equitable treatment of customers while fostering accountability. For your information.

<u>Human Resources Committee</u> The committee (Faines, Feimster & Taylor) met Thursday, November 14, 2024 to discuss the following agenda items:

Chief Deputy Mitchell shared that staffing is improving. He reported a significant increase in applications, and he is on track to fill all current vacancies. He also presented a pay progression plan that leverages the current funding for each position. This plan aims to provide growth opportunities for staff while staying within the existing budget.

Major Hawkins emphasized the need to focus on hiring experienced, "day 1 ready" officers. He also pointed out the importance of increasing the pay for supervisors, particularly Sergeants and Lieutenants—to retain experienced personnel. Aligning these pay rates with those of nearby Detention Centers would help us stay competitive with surrounding counties.

There was further discussion about implementing salary bonuses from Major Hawkins to reward those staff members that have weathered the storm of limited staffing. Manager Perry proposed a county-wide bonus for all departments, as opposed to limiting it to just one, to ensure fairness across the board. The committee also discussed equalizing pay between Deputy Sheriffs and Detention Officers to boost morale and retention for both roles.

In addition, we discussed offering shift differentials for staff working nights and weekends and utilizing lapse salaries to address high-vacancy positions within the department.

After a thorough discussion, the committee reached a consensus that we should hold off on any final decisions until the compensation study is completed. Once the study is available, we will have a clearer picture of how best to address the pay structure. In the meantime, the committee recommends presenting a one-time bonus plan for all county employees as an immediate recognition of their hard work to be processed effective December 13, 2024. Full-time employees would receive \$1000 and part time staff members would receive \$500. Recommendation: Approve the committee's recommendation to implement a county-wide bonus and the budget amendment in the amount of \$380,000.

<u>Properties Committee</u> The committee (Brummitt & Taylor; Alston absent) met Tuesday, November 19, 2024 to discuss the following agenda items:

Food Trucks on County Property. There have been several requests from local food truck vendors to utilize county property to sell food. To enhance community engagement and economic growth, the committee recommends creation of a policy to support food trucks on county property. This policy would allow licensed food trucks to operate in designated areas on government property while ensuring compliance with health and safety regulations and local zoning regulations. The policy should include clear guidelines for permits, operating hours, and waste management. Encouraging food trucks can create diverse dining options, support small businesses, and increase foot traffic to public spaces, fostering a vibrant and inclusive community environment. Staff will continue to work with the County Attorney to develop a policy for presentation to the committee and then to the Commissioners for consideration. For your information.

**Northern EMS Station Land.** Soil & Environmental Consultants, Inc. conducted a comprehensive soil and site evaluation for the proposed land intended for the Northern EMS Substation. The analysis confirmed that the soil composition is stable and suitable for construction, with no significant environmental concerns or impediments identified. The site's location, accessibility, and topography align with the operational and logistical needs of the EMS facility. **Recommendation:** Approve the purchase of the land based off the recommendations from the committee.

<u>Joint Public Safety/Fire Commission Meeting</u> The committee (Brummitt, Faines, Alston, Carpunky, and Small) met Wednesday, November 20, 2024 to discuss the following agenda items:

**Mutual Aid.** Committee members discussed all fire stations working together through the mutual aid agreements and identifying the areas that need support. Additionally, starting the process of adding the 4th FD to be dispatched to structure fires. **Recommendation:** Approve staff to coordinate with volunteer departments, fire association, and county staff to proceed with implementing the 4<sup>th</sup> fire department out for structure fires.

#### **Audit Committee Report**

#### 11/19/2024

**Committee Members Present:** Chairman Brummitt, Commissioner Taylor, Commissioner Hester, Amanda Spivey, and Mark Woodlief.

**Staff Members Present:** Stephanie Williams, Finance Director, C. Renee Perry, County Manager, Jeremy Jones, Assistant County Manager, Frankie Nobles, Special Projects Coordinator, and Kelly Grissom, Clerk to the Board/Executive Assistant.

Bank account, investment balances, interest rate, and YTD interest earned were shared with the committee. Truist bank account balance is earning 4.40% and the investments at NCCMT are earning 4.43%.

Chart of accounts, which is a list of all the financial accounts included in the financial statements of Vance County provides a way to categorize all of the financial transactions that a an organization conducted during a specific accounting period, was provided to those in attendance. There is still some review and some additional description and explanation that is to be provided to the audit committee. This will happen in January 2025.

**Insurance of Funds in Bank Accounts** – All of Vance County's deposits at Truist are held in Public Funds accounts. The State of North Carolina has laws requiring public funds to be held in these account types so that they are collateralized with assets on the bank's balance sheet.

Truist is collateralizing public fund deposit balances in excess of FDIC insurance with assets of the bank. They monitor the public fund deposit balances on a daily basis and adjust collateral if needed. The collateral is held by safekeeping agents (either Federal Reserve Bank or Wells Fargo)

Answers to the origination of the Traffic Crowd Control revenue from FY 22-23 audit and the expenditures of the Construction expenditures were provided.

- 1. For question number 1, this is G/L account 10-367-436716 Sales and Use Miscellaneous Refund.
- 2. Regarding question number 2, that total does appear to run back quite a number of years, appearing to have started in FY2016, though at the time it was referred to as "Jail Repairs", before subsequently being redesignated to "County Buildings" in FY2018, which likely could have encompassed both the Jail repairs and perhaps other projects the County was undertaking?

TPSA has agreed to meet with the audit committee. The Budget & Finance Director will schedule and communicate to the audit committee.

Soil & Environmental Consultants, Inc. (S&EC) performed a preliminary soil and site evaluation on the above referenced tract. This was performed at your request as part of the preliminary planning process in order to determine areas of soil that have potential for subsurface wastewater disposal per our agreement/contract dated October 3, 2024. Fieldwork was performed on October 25, 2024.

S&EC traversed the property and observed landforms (slope, drainage patterns, past use, etc.) as well as soil conditions (depth, texture, structure, seasonal wetness, restrictive horizons, etc.) through the use of hand auger borings. The site was evaluated during dry soil conditions. From these observations, an evaluation of the site was developed, relative to subsurface disposal of wastewater. Soil boundaries were estimated and sketched onto the map based on GPS data, site features, and topographic conditions. The soil/site evaluation criteria used is that contained in 15A NCAC 18E "Wastewater Treatment and Dispersal Systems".

#### **FINDINGS**

This site is located in the piedmont region of Vance County. The upland soils on this tract are similar to the Pacolet, and Rion soil series. The Pacolet soils have a sandy loam surface material over a clay subsoil. These soils are generally useable for subsurface septic systems. The Rion soils have shallow conditions to soil wetness and/or saprolite and are generally unsuitable for conventional type subsurface septic systems but may be used for alternative subsurface septic systems (such as low-profile chamber or drip).

The accompanying Sketch Soils/Site Evaluation map indicates the areas with potential use for subsurface wastewater disposal. The red hatched units indicate areas of soils which are at least 26 to 36+ inches deep to prohibitive soil characteristics and these areas have potential for Gravel Pipe, Accepted 25% Reduction Products (Standard Chamber or EZ-Flow), Panel Block (PPBPS), Low Profile Chamber, shallow placed drain lines (shallow placed lines with fill required over the disposal field), and/or Low Pressure Pipe (LPP) septic systems. The red hatched areas generally have soils supportive of long-term acceptance rate (LTAR) for Gravel, Accepted, PPBPS, or Low Profile Chamber septic systems of 0.25 to 0.30 GPD/SF and/or LPP/drip LTARs ranging from 0.10 to 0.12 GPD/SF.

The septic LTARs in given soil areas units may vary higher or lower than what S&EC has stated above based on specific lot evaluations/proposed septic areas. The ultimate LTAR and septic system type will be determined by the local health department and/or licensed soil scientist after their lot specific evaluation. Unit "UN" on the attached map indicates areas of soil that are less than 12 inches to prohibitive soil characteristics and/or has unsuitable landscape position and are generally unsuitable for the type of systems mentioned above. Some of the upland "UN" areas may have the potential for pretreatment surface drip. However, these are more expensive alternative septic systems options, and such systems are expensive, fall under different regulations/requirements and, if requested, S&EC can provide additional information concerning these types of systems.

The site plan for this lot must ensure that adequate soil area for system and repair is unaffected by site elements (building placement, driveway, parking areas, etc.) on that, or adjacent lots. The area ultimately designated by the health department or licensed soil scientist on the site plan for the septic system and repair must remain undisturbed (no mechanical clearing, excavation, heavy traffic, or other significant site disturbing activities) until authorized by the authorizing agent (local health dept, AOWE, or PE). A lot with initially adequate useable soil area may be rendered unusable as a result of improper site planning and/or disturbance. A field layout and/or septic design of the proposed septic system(s) may be required as part of the individual lot development process.

#### **GENERAL WASTEWATER CONSIDERATIONS**

Once potentially useable areas are located through vertical borings, the next consideration is the horizontal extent of those areas. The size and configuration of the useable soil area dictate the utility of that area. The size of a subsurface disposal field is determined by: 1) the design daily flow (DDF) from the source (commercial and industrial facilities DDF are based on the criteria in 15A NCAC 18E.0401), 2) the long term acceptance rate (LTAR) of the soil (based on the septic drain line lateral type, hydraulic conductivity of the soil or saprolite, the soil or saprolite texture, mineralogy, structure, porosity, etc.), and 3) the design/configuration of the septic system. Any wastewater system that meets one or more of the conditions within 15A NCAC 18E.0303 or due to local regulations shall be designed by a professional engineer (PE). The septic configuration must be such that an efficient layout of disposal lines (on contour) is possible. An additional consideration is the required setbacks for the system from various elements such as wells (50' to 100'), streams and ponds (50') or more (depending on watershed regulations), property lines (10'), watershed buffers, etc. (see Attachment 1).

For this soils/site evaluation, S&EC assumes the septic tank effluent entering the drainfield meets the standards for Domestic Strength Effluent (DSE) as defined by 15A NCAC 18E .0402 (and shown in the table below) unless a higher effluent standard is needed for the septic system(s) (such as advanced pretreatment using a standard of NSF/ANSI 40, TS-I, TS-II, or Reclaimed Water [RCW]). DSE is usually produced by the usual wastewater usage from a dwelling unit. Any septic tank effluent going to the drainfield exceeding the DSE standard below or any facility defined as having potential for generating high strength wastewater effluent as defined by 15A NCAC 18E.0401 shall be addressed in writing by a wastewater engineer.

The utility of a potential usable soil area for a subsurface system is most accurately determined by an on-ground layout of the proposed system. The total area needed for system and repair areas will depend upon the system type, the layout of that system and the total design flow (factors mentioned above).

According to the information provided, this lot is proposed to be used for an EMS substation. There may be 1 to 2 ambulances stationed there with 2 to 4 staff members in the facility. There will be bathrooms, kitchen and laundry in this facility. To determine the exact daily flow, spec sheets for the laundry and kitchen components will need to be reviewed. Also depending on laundry requirements and the proposed building specifications related to floor drains, will determine if the wastewater is considered as industrial process wastewater. S&EC recommends that the building plans and specifications be reviewed by either the local county health department or a wastewater engineer to determine the design daily flow and classification. Once the daily flow is determined then the amount or drainline required, plus the tank size can be determined. If the wastewater is classified as industrial process wastewater, then additional site testing such as in-situ hydraulic conductivity measurements, meeting with the county health department and State permitting agency.

This report discusses the general location of potentially useable soils for on-site subsurface wastewater disposal and, of course, does not constitute or imply any approval or permit as needed by the client from the local heath department. S&EC is a professional consulting firm that specializes in the delineation of soil areas for wastewater disposal, and the layout and design of wastewater treatment systems. As a professional consulting firm, S&EC is hired for its professional opinion in these matters. The rules governing wastewater treatment (interpreted and governed by local and state agencies) are evolving constantly, and in many cases, affected by the opinions of individuals employed by these governing agencies. Because of this, S&EC cannot guarantee that areas delineated and/or systems designed will be permitted by the governing agencies. As always, S&EC recommends that anyone making financial commitments on a tract be fully aware of individual permit requirements on that tract prior to final action.

An individual septic system permit will be required for this area prior to obtaining a building permit. This will involve a detailed evaluation by the local health department or a licensed soil scientist after a detailed site plan has been developed to determine, among other things, the building and parking lot location. Only after developing this information can a final determination be made concerning specifics of system design and site utilization.

This report and site evaluation is not conformant to the Engineered Option Permit (EOP), Authorized Onsite Wastewater Evaluator (AOWE) Permit Option, or the G.S. 130A-335(a2) hybrid private septic permitting process. Additional site testing and evaluations will be required to utilize a private septic permitting process and/or to obtain a septic permit from the local health department. The soil report and map associated with this project is for the exclusive use of the addressee and the use or reliance by all others is expressly denied without the written consent of S&EC.



Soil Suitability Sketch Map







## County Manager's Report

### Vance County County Manager's Report to the Board December 2, 2024

- A. PRIME Health Past Due Invoices. There are several outstanding safekeeping and jail health invoices from PRIME Health, the contracted provider for jail health services, dating back to 2019. These invoices, totaling \$352,000, were identified recently via notification from the Sheriff's Association. Upon investigation, it was determined that the previous Finance Director failed to process and pay these invoices. PRIME Health, during the same period, experienced staffing shortages that contributed to delays in their invoicing and communication processes. These compounding issues resulted in the invoices remaining unresolved. To address this matter, the Finance Department has worked closely with PRIME Health and the Sheriff's Office to validate all charges and establish a repayment schedule. Moving forward, procedural improvements, including enhanced tracking systems and regular reconciliation meetings with contracted service providers, are being implemented to prevent similar issues. We are committed to resolving this matter efficiently while maintaining our partnership with PRIME Health, ensuring continued high-quality healthcare services for the Vance County Detention Center. *Recommendation: Approve the budget amendment of \$352,000 from fund balance to process and pay past due PRIME Health invoices*.
- **B.** Jail Health Contract. Staff has been working closely with the Sheriff's office to review a six month extension on the jail health contract with the current provider ACH. The current contract is on a calendar year rotation, but we plan to solicit proposals for FY26. Staff recommends a contract that is fiscal year based so we can plan properly with each budget cycle. ACH is responsible for inmate healthcare to include professional medical, dental, mental health and related services to include regular sick call, nursing care, physician care, medical specialty services, emergency medical care, medical records management, pharmacy services management and other necessary health services. The current contract charges us for the average daily population. The detention center is consistently over capacity per Major Hawkins so our costs are increased significantly. **Recommendation**: Approve the budget amendment of \$470,000 from fund balance to fund overages from July 1, 2024 to December 31, 2024 and renew the contract for an additional six months through June 30, 2025.
- C. Neo-Gov Software. Effective recruitment processes are crucial for attracting and retaining top talent. However, the current Criterion recruitment software poses significant challenges that hinder efficiency and user satisfaction. We continue to have issues weekly that we are reporting but Criterion misses the mark consistently. The limitations of Criterion recruitment software are impeding on the effectiveness of our hiring processes. Staff has worked with the County Attorney to notify Criterion of the material breach of the contractual agreements. Transitioning to the NeoGov ATS will address these challenges, streamline workflows, and position our organization to attract and manage top talent more effectively. An investment in NeoGov is an investment in the future of our recruitment strategy. Transitioning to the NeoGov Applicant Tracking System (ATS) offers a solution to address these issues and enhance overall recruitment performance. This is a multi-year contract with year one reflecting NeoGov ATS only but year two includes NeoGov ATS and NeoGov PERFORM which is a performance tracking tool. The county currently uses an antiquated system to track

employee performance. *Recommendation*: Approve the budget amendment of \$7800.00 from fund balance to fund NeoGov Insight from January 1, 2025 through June 30, 2025 and authorize the County Manager to include the multi-year contract cost for Insight and Perform as indicated on the quotes in your agenda packets. For reference:

  b. Year 3: \$32,298.82
  c. Year 4: \$38,356.02
  d. Year 5: \$41,733.14
- **D.** County Manager Performance Evaluation. The performance evaluation for the County Manager is due as of November 1, 2024. The Chairman will coordinate the evaluation process with Argretta Johen, HR Director, and will be in touch with each of you to gather input and ensure timely completion. *For your information*.

### **Cooperative Extension – November 2024**

### Agriculture/Horticulture/Small Farms/Farmers Market

Our globe-trotting Ag agents have traveled near and far to bring you the latest in agricultural education- literally!

This month started with a visit to The International Horticulture Expo in Chengdu, China to learn more about how planned urban landscapes can exist in harmony with agriculture. There were also opportunities to learn about how local food systems are being influenced by developing industrial-scale agriculture and how emerging practices might be applied in Vance County.

As soon as the return flight touched down, it was off to Durham to attend The Sustainable Agriculture Conference hosted by Carolina Farm Stewardship Association where presenters shared the latest science behind sustainable agricultural practices. The networking events demonstrated that community leaders, change makers, and industry professionals all stand ready to serve those in need.

And from Durham, it was a short drive to Raleigh for yet another conference; this one focused on career development. Each Extension agent is charged with a mission to improve the lives of NC residents and N.C. Cooperative Extension knows that education and support are vital to an agent's success. Therefore, professionals from a wide range of backgrounds led presentations on how to be a more effective teacher, how to ensure program accessibility, and how to promote inclusivity with our outreach.

While we were in Raleigh, 2 local farmers joined us to attend NC A&T's Grassroots Leadership conference. The 2024 Grassroots Leadership Conference (GLC) was held on November 21 in Raleigh, North Carolina, at the Marriott Crabtree Valley. This one-day event brought together community leaders, volunteers, and professionals to discuss local issues and develop strategies for positive change. With the theme "Reimagining Community: Embracing Change and Exploring New Opportunities for a Path Forward," the conference focused on grassroots leadership in a changing world, addressing challenges like food insecurity, economic opportunity, and health concerns. Speakers will cover topics such as artificial intelligence, supporting small businesses, and building a more diverse workforce. The GLC aims to empower people from all backgrounds to create solutions for their communities and connect with resources to improve social, economic, and physical well-being.

One way NC State Extension is meeting the community needs is by maintaining an active farmers market and this past month has been busier than ever. The Handcrafted Holiday Market saw hundreds of people getting a jump on their holiday shopping, and the new "Storytime at the Market" series developed with Perry Memorial Library has been so popular that an additional event has been planned for December 7th. There's even a rumor that a *very* special bearded, red suit-wearing guest will be stopping by to enjoy gingerbread and hot chocolate. Of course, the facility hosts more than just the farmers market. On November 14th, Extension was proud to host many members of the Farm Bureau Board along with Representative Frank Sossoman as he announced the first annual NC Farmer Appreciation Day to be held on the second Thursday of November each year. The market also hosted an educational workshop where participants wiggled their way in to learn about Vermiculture and Vermicomposting. Topics included worm choice, proper care, and how to determine what food waste and materials can be safely composted.

From crawling to flying, the Vance Warren Beekeepers shifted focus to all things honeybee related for their monthly meeting at the market. Following the business meeting a guest presenter gave timely instructions on how to properly prepare the apiary for the cold weather quickly approaching.

If you're interested in becoming a beekeeper or just want to learn more, join the Vance-Warren Beekeepers for their next program, "So, You Want to be a Beekeeper?" at 6pm on December 9th at the Vance County Regional Farmers Market. Be sure to stick around for the December monthly meeting for a great chance to meet local beekeepers, learn more about the hobby, and hear the latest buzz from the beekeeping world.

### 4-H Youth Development / 4-H STEM

The Teen LEADS (Learning to Educate others About STEM) and Game of Drones programs have kicked off for the 2025 season!

Teen LEADS offers 4-H youth in grades 8-12 an opportunity to become leaders, effective communicators, and speakers, while becoming knowledgeable about STEM resources and activities. Participants create STEM activities to share with K-12 youth in the community. Teen LEADS earn incentives such as attending conferences or attending Space Camp in Huntsville, Alabama.

We are currently recruiting 4-H youth to participate in the 2025 Game of Drones season. Middle and high school youth compete in teams of three against several counties in North Carolina to complete missions using aerial drones, land drones, and Sphero Bolt robots. Teams prepare for the competition from January through April by learning how to use and program the drones and robots. The final competition will be held on April 12, 2025, in Greensboro, NC on the campus of NC Agricultural & Technical State University.

Vance County Cooperative Extension is excited to offer more opportunities to build our cooking and baking skills in 2025. If you are interested in sharing some of your knowledge by leading a class, we are always looking for volunteers and here to support our volunteers in any way we can.

### **Parenting Program**

During the month of November, the Supporting Father Involvement (SFI) program achieved several significant milestones. From October 28th through November 1st, staff members completed an intensive training hosted by the Bazelon Institute, equipping our team with the knowledge and skills to effectively implement the SFI curriculum. This comprehensive training underscores our commitment to enhancing family dynamics by supporting fathers in their critical role within the household.

We are proud to announce that the Mayor has officially proclaimed December 13th as Supporting Father Involvement Day, recognizing the importance of fatherhood in our community. This honor highlights the impact of the program and sets the stage for further engagement with local families. Additionally, we are in the final stages of hiring a dedicated Case Manager to support program participants and ensure the success of our services. Our first cohort of classes is scheduled to begin in January 2025, marking the launch of this transformative 8-week curriculum. Together, these developments position the SFI program to make a meaningful difference in the lives of families across Vance County.



11/11/24- Bailey and I attended a Veterans Day event at the Henderson Institute.

11/13/24- Veteran was awarded a monthly tax-free VA compensation payment of \$3,737.85 starting December 2024 and received a retroactive payment of \$69,830.30.

11/15/24- Military retirees and disabled veterans are set to see a 2.5% boost in their monthly payments in 2025, thanks to the annual Cost of Living Adjustment (COLA) that is linked to inflation.

11/20/24- The Department of Veterans Affairs (VA) has announced plans to investigate the potential connection between kidney cancer and exposure to per and polyfluoroalkyl substances (PFAS) at military bases. This research could pave the way for presumptive benefits to be offered to thousands of veterans affected by the disease.

If the study confirms a link, it would mark the first time the VA has fast-tracked benefits for a condition related to PFAS exposure. These chemicals, used in products like firefighting foam and water resistant clothing, have been prevalent on military installations for the past 50 years. PFAS exposure is already suspected to be a cause of various health issues, including testicular cancer and thyroid disease.
