#### COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, January 6, 2025 at 6:00 p.m. in the commissioners' conference room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those commissioners present were as follows: Chair Carolyn Faines, Commissioners R. Dan Brummitt, Yolanda J. Feimster, Thomas S. Hester, Jr., Leo Kelly, Jr., and Valencia L. Perry.

Absent: None

Also present were County Manager C. Renee Perry, Assistant County Manager Jeremy Jones, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Pastor Ron Cava, First Baptist Church, gave the invocation.

The first order of business was the election of vice-chair. Commissioner Thomas S. Hester, Jr. nominated Leo Kelly, Jr. Commissioner Leo Kelly, Jr. seconded the nomination. Commissioner Valencia L. Perry nominated Yolanda Feimster. Commissioner Dan Brummitt seconded the nomination.

Vote to appoint Leo Kelly, Jr. as vice-chair was ayes – two (2); noes – four (4), with the dissenting votes being cast by Commissioners Brummitt, Faines, Feimster, and Perry.

Vote to appoint Yolanda Feimster as vice-chair was ayes – four (4); noes – two (2), with the dissenting votes being cast by Commissioners Hester and Kelly.

Public comments were heard next. Bobby West with Grace Ministries requested funding from the board for his organization and provided an overview of the program.

Kim Weaver spoke about the poor condition of the roads in the Abbott Crossing subdivision and asked the board to look into what can be done to address this issue. She provided pictures, a site map and other related documentation.

Dottie Crocker and Mary Susan Williams expressed their concerns and spoke in opposition to the increase in property values and tax rate.

Lee Chandler asked the commissioners how many hours they work and to return their onetime employee bonus.

Angela Ryan asked how the opioid funds will be used. She also expressed her concerns with building a new jail and stated that inmates need to be processed in a timely manner in order to free up space.

Caroline Burnette asked how the opioid funds will be spent and why the jail inspection report was not provided to the board in a timely manner. She stated that a tax increase for a new jail is not appropriate. She also expressed her concerns with issues at social services.

Mr. Logan Parsons, LKC Engineering, appeared before the board and requested approval of a resolution of tentative award for Phase 1B. He explained that the resolution is for supplemental funding for Phase 1B.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Dan Brummitt, vote unanimous, to approve the resolution as presented.

- **BE IT FURTHER RESOLVED** that such TENTATIVE AWARD be contingent upon the approval of the North Carolina Department of Environmental Quality and associated grant funding with Project No. SRP-D-134-0054.

Mr. Parsons then informed the board that one area to be served in Phase 1B is the Abbott Crossing subdivision. He explained that a waterline is planned to be installed at the intersection of Shearin Lane and Abbott Crossing Lane. The road failure that was mentioned during public comments will be addressed at that time.

Economic Development Director Ferdinand Rouse informed the board of a grant opportunity with the North Carolina Railroad Company. He explained that the grant is for a total of \$40,000 (two \$20,000 grants) for site assessments for two vacant sites located within the Henderson-Vance Industrial Park. The assessments will consist of Phase 1 environmental, geotechnical, and wetlands delineation studies. No county match is required. He requested authorization to execute the grant agreements. County Attorney Jonathan S. Care stated that cost estimates for the assessments should be below \$20,000 for each site.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Valencia L. Perry, vote unanimous, to authorize the execution of the two grant agreements with the North Carolina Railroad Company for site assessments at the Henderson-Vance Industrial Park.

As advertised, a public hearing was held to gain citizen input on the FY 2025-26 Budget.

Caroline Burnette and Penny Stevens asked the board to reconsider the current tax rate and not spend money to redecorate the commissioners' room. Laura Perkinson asked the board to vote for a revenue neutral tax rate and not charge late fees to those who struggle to pay their taxes. Lee Chandler asked for a budget cut below revenue neutral. Angela Ryan asked for a revenue neutral tax rate or decrease and to consider every line item. Bobby West asked how much it costs for an inmate to go through the judicial system.

As there was no one else who wished to speak on this matter, Chair Carolyn Faines declared the public hearing closed.

#### Water District Board

Chair Carolyn Faines called the Water District Board to order. The November 2024 monthly operations report was presented to the board for information. Chair Faines adjourned the Water District Board.

#### Finance Director's Report

Quarterly Financial Report. Finance Director Stephanie Williams provided the quarterly financial report which outlined year-to-date revenues and expenditures and the comparison of each amount to the budget as amended. She also provided expenses by category.

## County Manager's Report

Fire Marshal's Office Budget. County Manager C. Renee Perry noted that during its August meeting, the board approved the creation of a separate fire marshal position based off the

fire study recommendations. The fire study highlighted critical areas where enhanced fire safety measures and oversight are essential to protect our residents, businesses, and infrastructure. To improve fire code enforcement, increase fire prevention education, enhance investigation capabilities, and streamline fire safety planning, staff is requesting a proposed budget of \$179,540 for the remainder of FY25. She provided a proposed budget for the board's review. Recommendation: Approve Budget Amendment #18 for \$179,540 from fund balance to create the budget for the Fire Marshal's Office.

Commissioner Dan Brummitt expressed his concerns that the budget includes funds for a vehicle. He stated that there are vehicles at the fire department that can be used for the fire marshal. Fire Marshal Chris Wright stated that there are no unused or unassigned vehicles at the fire department.

Motion was made by Commissioner Thomas S. Hester, Jr. to approve Budget Amendment #18 for \$179,540 for the Fire Marshal's Office. This motion was seconded by Commissioner Leo Kelly, Jr.

Commissioner Dan Brummitt stated that he would like to see the budget reduced by \$96,540 which is the budget for a vehicle, radio and upfit.

Vote to approve Budget Amendment #18 as presented was ayes – five (5); noes – one (1), with the dissenting vote being cast by Commissioner Dan Brummitt.

Personnel Policy Amendments. Ms. Perry stated that G.S. 143-805 requires public agencies to adopt a policy governing the use of its network, as well as the use of devices owned, leased, maintained, or otherwise controlled by that public agency, no later than January 1, 2025 to prohibit pornography from being viewed on its networks or devices. She noted that all of these policies must define the disciplinary actions that will be taken in response to a policy violation. Staff has worked with the county attorney to update the current technology acceptable use policy. Recommendation: Adopt the amended Technology Acceptable Use policy which now includes the mandated additions per G.S. 143-805 with an effective date of January 1, 2025.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Leo Kelly, Jr., vote unanimous, to adopt the amended Technology Acceptable Use policy which now includes the mandated additions per G.S. 143-805 with an effective date of January 1, 2025.

EEOC's Pregnant Workers Fairness Act Policy. Ms. Perry advised that as required by the Federal EEOC's Pregnant Workers Fairness Act, Vance County will provide reasonable accommodations to qualified employees and job applicants with known limitations due to pregnancy, childbirth, and related medical conditions, unless it would pose an undue hardship on the county's operations. This policy applies to applicants and all employees, regardless of employment status, who are pregnant, having recently given birth, or have related medical conditions covered under the Pregnant Workers Fairness Act. Recommendation: Adopt the proposed Pregnant Workers Fairness Act policy with an effective date of January 1, 2025.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner Valencia L. Perry, vote unanimous, to adopt the Pregnant Workers Fairness Act policy with an effective date of January 1, 2025.

Jail Inspection Reports. Ms. Perry reported that the state conducted its periodic jail inspections in 2023 and 2024. These reports were not brought to the board due to staff turnover in both the detention center as well as the county manager's office. She noted that the Sheriff is responsible for overseeing the jail, although it is necessary for the commissioners to receive the jail inspection report and be aware of potential budget items. County staff plans to have conversations with the board during its annual retreat to discuss a plan moving forward for the detention center. Recommendation: Act to receive the reports as information.

Motion was made by Commissioner Yolanda Feimster to receive the 2023 and 2024 jail inspection reports. This motion was seconded by Commissioner Thomas S. Hester, Jr. and unanimously approved.

Commissioner Dan Brummitt asked Sheriff Brame to provide a copy of the inspection responses to the board.

Northern EMS Substation Land. Ms. Perry noted that during its December meeting, the board tabled the purchase of land for a Northern EMS substation in order to have the land perk tested. Staff contacted the soil consultant who confirmed that 13,840 sq ft is suitable for a septic system.

Motion was made by Commissioner Dan Brummitt to move forward with the purchase of the land on Hwy 39 North for an EMS substation. This motion was seconded by Commissioner Valencia L. Perry.

Commissioner Thomas S. Hester, Jr. expressed his concerns with the topography of the land and stated that there may be additional expenses involved because of this.

After further discussion, vote to approve the purchase of the land was ayes – four (4); noes – two (2), with the dissenting votes being cast by Commissioners Thomas S. Hester, Jr. and Leo Kelly, Jr.

#### County Attorney's Report

Notification for Special Called Meetings. County Attorney Johnathan S. Care noted that during its December 30 special meeting, the board took action on appointments to the Henderson-Vance Economic Development Commission and the Henderson-Vance Industrial Park Board. He stated that since this item was not specifically listed on the agenda for the special called meeting, those votes were not allowed. He provided G.S. 153A-40 which states that unless all members of the board are present, only items that are specifically listed on the agenda may be acted upon. The agenda listed "other items as needed", but this is not sufficient unless all board members are present.

Commissioner Thomas S. Hester, Jr. informed the board that he will resign from the Henderson-Vance Economic Development Commission. These appointments will be brought back before the board during a future meeting.

Attorney Care also asked the board to let the clerk know how they wish to be notified of special called meetings.

Process for Board of Commissioners' Vacancies. Attorney Care then explained the process for appointing a replacement for the District 3 vacant board seat that was held by Sean Alston. He provided G.S. 153A-27 which states that the board has 60 days from January 1 to fill this seat. If a replacement is not named during this time, the clerk to the board is to notify the clerk of court who shall fill the vacancy within 10 days after the day the vacancy is reported to him.

He informed the board that staff will send a letter to the Vance County Democratic Party this week requesting them to assemble its Executive Committee to discuss and provide the county names of individuals who qualify and are fit to serve in this role.

He asked the board for feedback on this process and if they would like individuals to complete an application. The board agreed to this.
